ORDER

As per the Government Orders read as 1st and 2nd papers above, Government recognized the fee structure for various U.G. & P.G. Courses in Self Financing Arts & Science Colleges from the academic years 2013-14 and 2015-16 respectively.

Later Government ordered to include three courses viz. B.Sc. Industrial Fish & Fisheries, B.Sc. Biological Techniques and Specimen Preparation & M.Sc. Applied Fisheries and Aquaculture with Semester fee Rs.19,500/-, Rs.11,250/- and Rs.22,500/- respectively.

However, the effect of the said order was specified as from the academic year 2016-17 onwards.

Sri.Ram Prasanth M.R., former student, M.Sc. Applied Fisheries & Aquaculture course, St.Albert's College, Ernakulam, filed complaint No.HRMP 1812/16/EKM before the Hon'ble Kerala State Human Rights Commission, that he was denied scholarship by the SC Development Department as the Government Order does not cover his course period starting from 2013-14 onwards. The Hon'ble Kerala State Human Rights Commission ordered the Government to modify the Government Order so as to redress the grievance of the petitioner.

Government have examined the matter and are pleased to modify the order that the period of effect of the Government Order read as third paper above will be from the academic year 2013-14 instead of from 2016-17. The Government Order read as 3rd paper above, stands modified to this extent.
