ORDER

In the Centralized Admission Process for admission to MSW Programme for the academic year 2016-17, the University conducted a Counselling for the candidates in the rank list on 28th October 2016. Now the Principals of De Paul Institute of Science and Technology, Angamaly and the Principal, St Gregorios College of Social Sciences, Parumala vide letters referred to above stated that vacant seats still exist due to non-furnishing of options by the applicants for their colleges and requested for permission to fill up the vacancies on Spot Allotment basis at college level by dismissing with the requirement of Entrance Test.

The whole matter was examined by the CAP Monitoring Committee held on 7th November 2016 in detail and recommended to the Honøble Vice Chancellor to amend the Regulations of MSW for dispensing with the Entrance Test and permitting the colleges to fill up the vacancies remaining after the Admission Counselling.

Hence the Honøble Vice Chancellor, exercising the powers under Section 3.10(17) of Mahatma Gandhi University Act 1985, accorded sanction for permitting the colleges concerned to fill up the vacant seats for MSW(based on *inter se merit*) by dispensing with the requirement of Entrance Test.

Preference shall be given to candidates who have figured in the rank list published by the University. While admitting the candidates who have figured in the rank list published by the University, permission of the University for Late submission of application shall not be insisted upon. Permission of the University is mandatory in the case of candidates who have not figured in the rank list published by the University. The admission process shall be completed as per the schedule prescribed by the University for the Centralized Admission to PG programmes in the affiliated colleges(PGCAP).

The fee due to the University shall be levied from the candidates admitted as in the case of college-level admissions.

Orders are issued accordingly.
