ORDER

Smt. Nisha Vellapan Nair , candidate who got registration for Ph.D programme in 2006 and awarded degree subsequently , has submitted a request to issue her a certificate as per UGC regulation read as paper I above exempting her from the requirement of minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Asst Professor or equivalent positions.

The university Research Committee considered her request and perused the relevant provisions of the said regulation which provided for issuing certificate to candidates who had registered for Ph.D programme prior to 11th July, 2009 exempting them from the requirement of NET/SLET/SET for appointment to the post of Asst. Professor in universities and colleges or equivalent positions subject to the fulfillment of the following conditions:-

- a). Ph.D degree of the candidate awarded in regular mode only.
- b). Evaluation of the Ph.D thesis by at least two external examiners.
- c). Candidate had published two research papers out of which at least one in a refereed journal from out of his/her Ph.D work.
- d). The candidate had presented two papers in seminars/conferences from out of his/her Ph.D work.
- e). Open Viva Voce of the candidate had been conducted.

The Committee resolved vide paper II read above to recommend to authorise the Director of Research to verify the conditions a) to e) and to issue the certificate to the candidate and also in similar other cases. The candidate has to submit an application for the same, duly verified and recommended by the research guide, addressed to the Director of Research, remitting an amount of Rs.100/-(One hundred only).

The above recommendation was approved by the Hon'ble Vice-Chancellor.
