ADMISSION NOTIFICATION

Applications are invited for admission to the LL.B. (Regular) Programme offered at the School of Indian Legal Thought, for the academic year 2010-11.

The details regarding the course are as follows:

Duration of the course : 3 Years spread over 6 Semesters.
Timing : 4 PM – 9 PM, Monday to Saturday (10 AM to 5 PM
for the Sixth
Semester)
No. of seats : 50

Eligibility criteria :

Graduate in any discipline with not less than 45% marks in aggregate (40% for SC/ST candidates).

All candidates including those who are employed shall give a written undertaking at the time of admission to the effect that they would abide by the timing of the course. The candidates who are employed shall produce supporting documents to prove the nature of employment or profession and a 'No Objection Certificate' from the employer.

Mode of selection :

Admission to the course will be made from the rank-list prepared on the basis of the marks obtained in the Entrance Test conducted by the School.

Entrance Test (2 hours duration carrying hundred marks) intended to test the general knowledge, logical reasoning, language skills, etc.

Tuition Fee : Rs. 6,000/- per semester.

Registration fee for the course is Rs. 350/-. SC/ST candidates need pay only Rs. 175/- as registration fee.

Candidates should remit the REGISTRATION fee at the UNIVERSITY CASH COUNTER/FRIENDS JANASEVANAKENDRAM or by way of D.D. drawn in favour of the FINANCE OFFICER, MAHATMA GANDHI UNIVERSITY, PAYABLE AT SBT, M.G. UNIVERSITY CAMPUS BRANCH (Code No. 669), P.D. HILLS P.O., KOTTAYAM. Full postal address of the applicant, with Pin code, shall be entered on

the reverse side of the DD in BLOCK LETTERS. Fee once remitted shall not be refunded.

Only the courses and their equivalents approved by the Mahatma Gandhi University shall be reckoned as eligible qualification. Those who have qualified from Universities other than Mahatma Gandhi University should produce eligibility/recognition certificate from this University and Migration Certificate/NOC from parent University at the time of admission.

Copies of documents to prove qualification/age/caste and other relevant certificates should be attached along with the application. Original documents should be produced at the time of interview/admission.

No rounding of percentage of marks to the nearest whole number is permitted.

Candidates awaiting final year results of qualifying examination can also apply, provided they shall produce mark list of the qualifying examination at the time of admission.

Reservation of seats, Weightage of marks, Relaxation in minimum marks based on income, caste, etc., will be allowed according to the rules of the University.

Duly filled up applications, along with the Registration fee (DD/Pay-in-slip), a self-addressed stamped (Rs. 5/-) envelope and relevant documents should be forwarded to the Director, School of Indian Legal Thought, Mahatma Gandhi University, Soorya Kalady Hills, S.H. Mount P.O., Kottayam – 686 006. The filled up application form should be complete in all respects. Defective and incomplete applications will be summarily rejected.
