ORDER

1. Vide G. O. referred to at (4) above, the Government had extended to the State Government Officials and Employees and Directors of Public Sector Undertakings, Co-operatives and Autonomous Bodies under the State Government, the Daily Allowance Rates and other related instructions for tour abroad as laid down by Government of India vide references (2) and (3) above.

2. It is now seen that the Government of India has, vide order read (5) above, reduced with effect from 24-9-2000 the Daily Allowance Rates by 25% across the board. The details are given in the Appendix.

3. Accordingly, the Government are pleased to order that the above reduced rates shall also apply to the State Government Officials and employees and Directors of Public Sector Undertakings, Statutory Agencies/Bodies, Co-operatives and Autonomous Bodies under the State Government. This will

apply to all cases where the accounts of the tour undertaken are yet to be settled as on the date of this order.

4. Government also order that in future, revision of rates or instructions by the Government of India in this regard will automatically apply to the State Government Officials and Employees and Directors of PSUs, Statutory Agencies/Bodies, Corporations and Autonomous Bodies, under the Government.
