## **ORDER**

Following the amendments to Clause 4.4.1(iii) of University Grants Commission on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in higher education, (3<sup>rd</sup> amendment), Regulations 2016, order read as paper (1) above was issued authorising the Director of Research to issue a certificate exempting research scholars registered for Ph.D programme prior to 11<sup>th</sup> July 2009 from the requirement of minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Asst Professor or equivalent positions. In order to circumvent the delay in issuing the certificate, order read (2) above was also issued for the procedure to be followed in this regard.

The certificate issued by the Director of Research was, however, rejected by the University Grants Commission as the Director of Research was not one of the four authorities authorised by the Commission to issue such a certificate. The University Research Committee held on 29/05/2017 considered the matter and resolved, vide paper read (3) above, to recommend to modify U.O.No. 5915/AcAX/3/NET/Exempt/2016 dated 09/11/2016 and cancel the U.O No. 6089/Ac.AX/3/NET/Exempt/2016 dated 18.11.2016 and to authorise the Pro -Vice - Chancellor to issue the above certificate.

The recommendation of the University Research Committee was approved by the Vice-Chancellor.

Order read (1) above stands modified to this effect.
