<u>ORDER</u>

Vide the letter read (1) above, One hundred and eighteen post of Assistants were reported to the Kerala Public Service Commission consequent on the provisions of the Kerala Public Service Commission (Additional function as respects the Services under the Universities) Act 2016 and the G.O. read (3) above

Accordingly, the Secretary, Kerala Public Service Commission vide letter cited (4) above, has advised 118 candidates for selection to the posts of Assistants, provisionally, on Scale of Pay of ₹27,800 − 59,400/- in the University.

Appointment Orders in Memo read (6) above were issued to One hundred and eighteen candidates subject to conditions as per rules and one hundred and eight candidates have reported to join duty within the time limit specified. Sri.Ratheesh V (Sl.No. 69) Sri.Mijo Mon T M (Sl.No.52) Sri.Ajith A N (Sl.NO.17) and Sri.Diluseelan D (Sl.No.110) have been granted extension of joining time for 45 days w.e.f 20.09.2016, vide the U.O read (7) above as per rules.

The Secretary, KPSC, vide letter read (8) above, as per the provisions in rule 3(c) of KS&SSR has informed that advice memo served to Smt. (P) No. 20/2013/Fin dated 07.01.2013, except to those who were appointed in substantive vacancies on regular basis on or before 31.03.2013 and who were in such posts on 31.03.2013 and to whom the KSR, Part III Pension Scheme applies in their respective institutions.

3. The Assistants appointed on provisional basis shall be on probation for a period of two years of duty within a continuous period of three years as per the provisions in the G.O (P) No.7/2016/H.Edn. Dated, 26/02/2016 and all the other conditions of service are governed by the provisions in the MGU Statutes 1997.

Orders are issued accordingly.
