ORDER

The Registrar, APJ Abdul Kalam Technological University vide paper read (1) submitted the following norms to admit the B.Tech/ M.Tech students who have discontinued their studies in the parent University.

- (i) The student should have been eligible for readmission had the programme continued in the parent University as per the regulations of the respective Universities. A certificate to prove the eligibility for readmission from the parent University has to be produced by the applicant for admission to Kerala Technological University.
- (ii) Admission to KTU shall be strictly based on the recommendation of the Principal of the college from where the applicant has discontinued the study.
- (iii) A committee constituted by KTU to examine readmission cases shall decide on addition and/or substitution of courses to be studied by the student to match with the curriculum of KTU, subject to the ratification of the Academic Committee.
- (iv) The credits earned by the student in the parent University shall be transferred to KTU as per clauses in the ordinance of the respective programme. The credits earned by the students in the parent University shall be converted to equivalent credits of KTU as per the pattern of credits assigned by KTU in the ordinance.
- (v) The rules and regulations applicable to the batch of students to which the student is admitted shall be applicable to him/her.
- (vi) The students who have completed all courses up to the last but one semester may be allowed to continue in the parent University. The parent University

may award the degree in such cases and the Colleges may arrange classes for such students.

The Vice Chancellor approved the norms of readmission (i) to (v) submitted by the Registrar, APJ Abdul Kalam Technological University, and the UO read (2) was issued, and ordered to place the norm (vi) submitted by the Registrar, APJ Abdul Kalam Technological University before the Academic Council.

The Academic Council vide minutes read (3) has resolved to approve the following recommendations of the Registrar, APJ Abdul Kalam Technological University, Thiruvananthapuram, to admit the B.Tech/ M.Tech students who have discontinued their studies in the parent University. "The students who have completed all courses up to the last but one semester may be allowed to continue in the parent University. The parent University may award the degree in such cases and the Colleges may arrange classes for such students."

The Syndicate vide minutes read (4) has resolved to adopt the resolution of the Academic Council held on 18.06.2016.


