**ORDER**

The Government of Kerala vide GO read as (1) accorded sanction to affiliate all the technical institutions imparting B.Tech and M.Tech courses in the State, to the Kerala Technological University from the academic year 2015-16 onwards. Further sanction has been accorded, allowing the institutions imparting B.Tech and M.Tech course to continue affiliation in the existing Universities in Kerala for the existing courses till the students already admitted to the course complete their studies.

The Registrar, APJ Abdul Kalam Technological University vide paper read as (2) submitted the following norms to admit the B.Tech/ M.Tech students who have discontinued their studies.

- (i) The student should have been eligible for readmission had the programme continued in the parent University as per the regulations of the respective Universities. A certificate to prove the eligibility for readmission from the parent University has to be produced by the applicant for admission to Kerala Technological University.
- (ii) Admission to KTU shall be strictly based on the recommendation of the Principal of the college from where the applicant has discontinued the study.
- (iii) A committee constituted by KTU to examine readmission cases shall decide on addition and/or substitution of courses to be studied by the student to match with the curriculum of KTU, subject to the ratification of the Academic Committee.
- (iv) The credits earned by the student in the parent University shall be transferred to KTU as per clauses in the ordinance of the respective programme. The credits earned by the students in the parent University shall be converted to equivalent credits of KTU as per the pattern of credits assigned by KTU in the ordinance.

- (v) The rules and regulations applicable to the batch of students to which the student is admitted shall be applicable to him/her.

Considering the above, the Vice Chancellor has approved the norms of readmission (i) to (v), submitted by the Registrar, APJ Abdul Kalam Technological University.

Orders are issued accordingly.
