ORDER

To bring uniform pattern for admission to UG/PG Programmes, sanction has been accorded by the Hon' Vice Chancellor exercising power u/s 3.10 (17) of Mahatma Gandhi University Act 1985, to dispense with the Entrance Examinations and Interview prescribed in the Scheme and Syllabus/Regulations of the above mentioned Programme and to bring the same under the purview of CAP w.e.f. 2016-2017, under instruction to report the matter to the Syndicate/Academic Council.

Further, sanction has also been accorded by the Hon' Vice Chancellor exercising power u/s 3.10 (17) of Mahatma Gandhi University Act 1985, to follow the admission procedures implemented by the University for M.S.W. admissions in affiliated colleges to the below mentioned courses also under instruction to report the matter to the Syndicate/Academic Council.

Orders are issued accordingly.


