ORDER

In continuation to the U O read (1) above, a meeting was convened to formulate guidelines on the basis of directions of the Police authorities for engaging workers including migrant labourers in the University Campus for various construction works. The meeting referred (2) has discussed the apprehensions of the female students and the instructions given by the police authorities on the above issue and hence resolved to take the following decisions:

(1) Most of the labourers engaged by CPWD in construction are seen to be migrants of other states. They may include infiltrates from neighboring countries as well posing threat on national security. According to the above instructions given by the Police authorities all the Agencies / Contractors are to provide copies of the I D proofs of all the labourers to be submitted before the University authorities and that of migrant labourers after proper verification by the police to assure security measures. The copies of the ID Proof have to be forwarded to Security Officer through UE (i/c).

(2) Eventhough the MoU permits to provide site for labour huts, the construction agencies cannot build it at their own chosen places without seeking permission from the University authorities. Hence by building the labour huts, their action became arbitrary and illegal. Therefore the labour huts built without permission has to be demolished on or before 16-05-2016 without any further notice.

(3) To convene an urgent meeting with Chief Engineer and Superintending Engineer of CPWD for addressing the issues.

(4) As the demand for two shifts is not included in the MoU and the completion of the work can be attained by engaging additional labourers, request to change the work time schedule cannot be considered.

(5) The Labourers had destroyed the Flora & Fauna and cut down the trees without permission and thus spoiled the Jeevaka Bio Laboratory in the Campus.

(6)The request for extension of time for evacuation is considered and it is decided to extend the date for evacuation to 16.05.2016. The University Engineer (i/c) is entrusted for the proper evacuation in time The Security Officer shall give all possible help to University Engineer to evacuate the labourers with the help of Police, if necessary and submit a status report after evacuation.

(7) The electricity and water connections to labour huts has to disconnect after 16.05.2016.

The Hon Vice Chancellor examined the Minutes and approved on 12.05.2016.

Orders are issued accordingly.
