| <p><b>Statute 14-Age limit for direct appointment</b></p> <p>The minimum age limit and the maximum age limit for appointment by direct recruitment of Assistant Professors in private Aided Arts and Science Colleges shall be 22 (Twenty two) and 36 (Thirty six) respectively as on the first day of July of the year in which applications for appointments are invited, with the usual relaxation of age limits to members of SC/ST/OBC communities as in Government service.</p> <p>Provided that the upper age limit shall be relaxable by five years, in the case of persons who are in service as teachers in Government/Private Aided High Schools, Government/Private Aided Vocational Higher Secondary Schools and Government/Private</p> | <p><b>Statute 14-Age limit for direct appointment</b></p> <p>The minimum age limit and the maximum age limit for appointment by direct recruitment of Assistant Professors in private Aided Arts and Science Colleges shall be the same as that followed by the State Government in making appointment to the post of Assistant Professors in Government Colleges, as amended from time to time with the usual relaxation of age limits to members of SC/ST/OBC communities as in Government service.</p> <p>Provided that the upper age limit shall be relaxed by a maximum of five years/or to the extent of length of regular service on the date of application, in the case of persons who are in service as teachers in Government/Private Aided High Schools,</p> |
