His Excellancy, the Chancellor has been pleased to assent on 10.12.2015 to the amendment to Statute 14 of Chapter 45 of the Mahatma Gandhi University Statutes, 1997 regarding the enhancement of the upper age limit for recruitment of teachers to all Government/Private Aided Colleges in tune with the relevant Government Orders.

IN THE MAHATMA GANDHI UNIVERSITY STATUTES, 1997- Statutes 14 of Chapter 45 Part-B-Conditions of service of teachers in Private Colleges.

Statute 14-Age limit for direct appointment

Statute 14-Age limit for direct appointment

The minimum age limit and the maximum age limit for appointment by direct recruitment of Assistant Professors in private Aided Arts and Science Colleges shall be 22 (Twenty two) and 36 (Thirty six) respectively as on the first day of July of the year in which applications for appointments are invited, with the usual relaxation of age limits to members of SC/ST/OBC communities as in Government service.

The minimum age limit and the maximum age limit for appointment by direct recruitment of Assistant Professors in private Aided Arts and Science Colleges shall be the same as that followed by the State Government in making appointment to the post of Assistant Professors in Government Colleges, as amended from time to time with the usual relaxation of age limits to members of SC/ST/OBC communities as in Government service.

Provided that the upper age limit shall be relaxable by five years, in the case of persons who are in service as teachers in Government/Private Aided High Schools, Government/Private Aided Vocational Higher Secondary Schools and Government/Private

Provided that the upper age limit shall be relaxed by a maximum of five years/or to the extent of length of regular service on the date of application, in the case of persons who are in service as teachers in Government/Private Aided High Schools,
