It is hereby notified that the Hon'ble Chancellor vide reference 1, has affirmed that so long as the nomination of a member to the Syndicate under section 21 "Other members" ( b) is not withdrawn/ cancelled by the Chancellor or the nominee has not otherwise ceased to be a member of the Syndicate by virtue of any statutory provision, the member nominated shall hold office for a full term of four years from the date of nomination under section 22 (1) of the Mahatma Gandhi University Act 1985. There fore, the nomination of Prof .(Dr. ) T.V Thulasidharan as a member of Syndicate, made by the Chancellor on 05-08-2014 entitles him to hold office for a term of four years from the date of nomination, unless the same is withdrawn by the Chancellor. Since his re-nomination as Dean of Faculty is valid and well within the periods mentioned in the proviso to Section 22 and also in consideration of the precedents in this regard, there is no requirement for a re-nomination of Prof .(Dr. ) T.V Thulasidharan as a member of the Syndicate before the expiry of term of four years provided under Section 22(1) of the Mahatma Gandhi University Act 1985.
