ORDER

Sri. Nivin Remold P, a candidate for B.A. Sociology during 2011-2014. discontinued the studies at the third year due to an accident and could not continue studies.

The annual scheme for UG Courses under the private stream came to an end with the 2011-14 batch. Vide U.O read 2 those who discontinued after the second year study of private registration were allowed to take re-admission to third year and to appear for the final year supplementary examination and treat it as their first chance in March 2015. This candidate could not utilize this chance due to personal reasons. Vide the paper read 1, he has requested to permit him to appear in the coming mercy chance examination.

Vide U.O. read 3, the private registration candidates who had not been registered for the examination of a particular year/semester, were allowed Notional Registration for that examination, with a condition that he/she should apply for the same within two months after the completion of the examination.

The Vice Chancellor has accorded sanction to:

(a) Permit all private candidates who could not apply for Notional Registration within the time limit stipulated (two months) to apply for the same for the discontinued year/semester

(b) Permit all private candidates who had submitted applications for Notional registration two months after the completion of examinations, to appear for the regular examination of the subsequent semester/year (with the junior batch if the syllabus/ scheme continues)/supplementary/ mercy chance examinations.
