THE MAHATMA GANDHI UNIVERSITY STATUTES, 1997

In exercise of the powers conferred by Section 23 (ii) of M.G.University Act, 1985, the Syndicate of the University at its meeting held on 30.6.2011 (Minutes item No.78/11.05/4394) passed the following amendments to the Mahatma Gandhi University Statutes, 1997. The Honourable Chancellor gave his assent to these amendments on 21.7.2016, as intimated by the Secretary to Governor, vide letter No.GS3-1638/2011 dated 22.7.2016. These amendments shall come in to force with effect from 21.7.2016.

| <p>1) The recruitment to posts shall be made on the basis of the recommendations made by a Selection Committee consisting of (i) Vice-Chancellor as Chairman, (ii) Convener of the Standing Committee of the Syndicate on staff (iii) The SC/ST member of the Syndicate and (iv) Registrar who shall be the Member-Secretary of the Committee.</p> <p>2) The Committee may conduct a test and/or interview as and when deemed necessary.</p> | <p><u>Amended Statute 8.</u></p> <p>Recruitment to all non-teaching posts in the University shall be made by the Kerala Public Service Commission.</p> |

| <p>1) The Selection Committee, if it considers necessary that a short list of the applicants is necessary the committee may screen the applications received and prepare a short list provided that the number of the applicants in the short list shall not be less than five for each vacancy. The committees referred to in Statutes 8 above may decide whether the applicants to be called for interview be given T.A. and incidental expenses.</p> | <p>The Syndicate of the University shall report to the Kerala Public Service Commission, the vacancy position in respect of various Non-teaching posts in the University at regular intervals.</p> |

2) The committee shall while making the selection and appointment observe the principles prescribed as per the provisions of clauses (a), (b) and (c) of rule 14, 15 to 17 of the Kerala State and Subordinate Service Rules, 1958 as amended from time to time.

3) Notwithstanding anything contained in the Act or the Statutes, the University may reserve a specified number of posts in any class, category or grade to be filled by direct recruitment exclusively from among the members of Schedule Castes and Schedule Tribes.
