Sri. Jijo George who claims to have a Doctorate in Management from Pondichery Central University has applied for Private Registration for M.A. Economics during 2014-2015. As per the U.O read 2 above, candidates having M.Phil/Ph.D from Mahatma Gandhi University were permitted to appear for the P.G. Degree examinations with a view to take an additional P.G. Degree provided the marks secured by such candidates in the Additional P.G. Degree examination will not be considered for Ranking. The application for Private Registration from the candidate was rejected.

Now, vide the request read 1 above, the candidate has requested to change the policy of the University, so that a candidate with a higher qualification could study for lower Degree, in this era of multidisciplinary research.

The meeting of the Academic Council vide minutes read 3 above, has resolved the following.

'Candidates who wish to register for any P.G examination of Mahatma Gandhi University under Private/ Regular Stream can be allowed to do so even though he/she has passed any examination from other Universities or this University which is considered to be higher than for which he/she desires to register for, with the following conditions.

- 1. Candidates who have been awarded a PG Degree by Mahatma Gandhi University in a particular subject shall not be permitted to register for the same subject.
- 2. The marks/Grades scored by such candidates will not be considered for determining up to tenth position.
- 3. He/ she should have fulfilled the eligibility conditions for admission to courses for which he/ she wishes to register for the examinations.

The meeting of the Syndicate held on 1/2/2016 vide minutes item read 4 approved the same.
