The CSS Section has forwarded vide note read as (1), the draft of the Revised CSS (Credit & Semester System) Regulations approved by the Revision Committee vide Minutes read as (2), Mahatma Gandhi University following the guidelines of UGC for the implementation of the CSS which became operational since 2002-03.

The Mahatma Gandhi University - CSS applies to all academic programmes of the Statutory Departments/Schools/Centres/Institutions of the University with flexibility to introduce new generation programmes such as integrated graduate – prost graduate and post graduate – research programmes.

Revision to the existing comprehensive Regulations of the Credit & Semester System (CSS) has been carried out to ensure functional autonomy of Statutory Schools/Centres/Institutes.

Programmes of all the existing Statutory Schools/Centres/Institutes and any other similar ones that may be started in the future shall also be covered by this revised CSS Scheme w.e.f. 2016 admissions. The CSS Academic Advisory Committee meeting held on 15.04.2016 vide minutes read (3), resolved to accept the changes proposed in para 8.2 (of the draft) regarding appointment of External Examiners incorporating the word 'approved by the Hon'ble Vice Chancellor' instead of faculty council and deleting 'with due intimation to the Hon'ble Vice Chancellor' in the draft regulations.

The Academic Council meeting held on 18.06.2016 resolved, vide minutes read as (4), to approve the revised CSS (Credit and Semester System) Regulations w.e.f.2016 admissions.

The meeting of the Syndicate held on 12.08.2016 has resolved, vide minutes read as (5), to adopt the resolution of the Academic Council held on 18.06.2016.
