ORDER

The Muslim Educational Society, Bank Road, Calicut, submitted an application vide paper read (1) above, for starting the un-aided/Self Financing Arts & Science College, under the name and style 'MES College Kochi' at Mundamveli, Palluruthy, Kochi-682 507 with the new unaided programmes, 1. B.Com with Taxation (40 seats), 2. B.Com with Computer Application (40 seats) and B.B.A for the academic year 2015-16. The application was submitted after the last date and the same was considered later by the University and Inspection Commission was constituted vide U O read (2) above, to assess the instructional & infrastructural facilities provided by the Educational Agency to start the proposed College. The commission submitted report specifying the model of the courses and the matter of affiliation of the college was forwarded for the views of Government of Kerala vide paper read (3) above.

The Government of Kerala has not offered any views on the starting of the new Unaided Self financing Arts & Science College.

Later, the Hon'ble High Court of Kerala after interim orders in different cases issued an order vide paper (6) above to grant provisional affiliation to MES College Kochi pending disposal of the writ petition and the petitioner is permitted to admit the students provisionally on or before 15.09.2017. The Hon'ble Court has considered the re-inspection report, read as paper (4) above before issuing the present order.

In the light of the order of the Hon'ble High Court, the Syndicate sub-committee on affiliation and approval as per paper read (7) above resolved to recommend to temporarily affiliate MES College Kochi with BBA(40 intake), B.Com with Computer Application (40) and B.Com. with Finance and Taxation(40) for the academic year 2017-18 and resolved to direct the college to complete the entire admission process by following the rules and regulations in this regard by the college itself. The admission shall be completed before 15.9.2017.

The Vice-Chancellor exercising powers under section 3.10(17) of Mahatma Gandhi University Act 1985 has approved the above recommendations.

Sanction has therefore been accorded to grant provisional affiliation to the new Unaided Arts & Science College, 'MES College Kochi', Mundamveli, Palluruthy, Kochi-682 507 under Muslim Educational Society, Bank Road, Calicut with the Unaided Self financing programmes, mentioned

below for the academic year 2017-18. The model of the courses is shown as per the inspection report

read paper (2) above.

Provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted for a period of one academic year only.

2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.

3. The Educational Agency shall set apart 50% of the seat of the courses being filled up by the Government or such authority determined by the Government and the remaining 50%

filled up by the Educational Agency on the basis of merit.

4. The Management shall collect the Tuition Fee and remit the fees due to the University as follows:

a)

- b) Students' Insurance Premium @Rs.23/- per student per year
- c) Students' Welfare fund @Rs.30/- per student per year.
- d) University Union Fee @ Rs.50/- per student per year
- e) Sports Affiliation Fee @Rs.300/- per student per year to be utilized in the ratio 2:1 by the University and the College.
- f) Students Affiliation Fee @ Rs. 400/- each for U.G Courses on one time basis shall be collected at the time of admission from all students and shall be remitted to the University with in Fifteen days after closing of the Admission.
- g) Collection of Annual Administration Fee from the students under any circumstances is not permitted.
- 5. Changes (if any) in the rate of Tuition Fee will be intimated later.
- The Educational Agency shall remit Rs. 2,00,000/-(Rupees Two Lakhs only) in Mahatma Gandhi University Fund towards Initial Affiliation Fee for college and course affiliation fee of Rs.20,000/-(Rupees Twenty thousand) each for B.Com and Rs.40000/-(Rupees Forty Thousand only) for BBA.

- 7. The Educational Agency shall furnish a Financial Guarantee of Rs. 3,00,000/-(Rupees Three Lakhs only) as provided in Mahatma Gandhi University Statutes, 1997, by way either of the following:
 - a) Cash Deposits
 - b) Fixed Deposit in the State Bank of India or in any of the Nationalized Banks, having Acquisition and Transfer of Undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
 - c) Government Securities
 - d) Saving Certificates, National, Postal or Defense Bonds in favour of the Finance Officer.
 - e) Mortgage of the title deed of immovable property other than the College sites, buildings/hostels where such in mortgage is permitted under any law for the time being forced.
 - 8. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 200/to the effect that it will abide by the rules, regulations and instructions issued by the University, State Government, Regulatory Body regarding the admissions to the courses from time to time.
 - 9. The College shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
 - 10. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning affiliation.
 - 11. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the affiliation without any notice.

Orders are issued accordingly.
