ORDER

As per the Order dated. 21.08.2017 read as (4) above, the Division Bench of the Hon. High Court of Kerala observed that the University authorities are prima facie in contempt and directed the University to fully comply with the Judgments before 29.08.2017.

Pursuant to the order of the Hon. High Court, the Vice Chancellor has issued orders for the immediate compliance of the Judgment. It has been directed to grant service benefits as ordered by the Learned Single Judge and later affirmed by the Division Bench of the Hon. High Court of Kerala.

There are 54 Petitioners in 19 Writ Petitions, who had been engaged on contract basis in the Self Financing Institutions formerly run by Mahatma Gandhi University. A Special Cell has been constituted to fix and quantify the service benefits due to the petitioners pursuant to the Judgments of the Hon. High Court.

The Vice Chancellor in exercising of the powers conferred on him under Section. 10(17) of the Mahatma Gandhi University Act, 1985 has ordered to disburse the amount due to the Petitioners. The disbursal will be effected immediately on receipt of the report from the Special Cell constituted to quantify the amounts due to each petitioner. As an interim measure pending receipt of the report of the Special Cell, the Vice Chancellor has ordered to release an amount of Rs. 5 lakh each to the petitioners. The Finance Officer is authorized to make the payments after effecting Statutory deductions if any from the Head of Account 22 101 01 Salaries and Allowances provided in the Budget estimates of the Financial Year 2017-18. Excess amount if any received by any of the petitioners over and above the eligible amount will have to be refunded.

Orders are issued accordingly.
