ORDER

As per U.O. No. read above, Scale of Pay salary and other benefits were sanctioned to the teachers of Self Financing Institutions formerly run by the University in full compliance of the judgment dated. 07.12.2016 of the Hon. High Court of Kerala in W.P.(c). No. 19540/2009and related cases. At Sl. No. 40, Paragraph 17(a) of the said U.O., the date of joining of Smt. Kochurani Jacob, SME, Angamaly was erroneously entered as 14.01.2007 instead of 14.01.1997, following which corresponding errors occurred in the dates of qualifying service, grant of Scale of Pay and declaration of Probation. Apart from this some errors occurred in the annexure too. The amount due to Smt.Swapna .M ,Smt.Soya Sadanandan and Smt.Kochurani Jacob is wrongly entered as Rs.27,29,041/ ,Rs.16,63,674/ and Rs.11,88,119/ respectively instead of the actual amount of Rs.28,85,846/,Rs.18,94,656/ and Rs.33,14,563/.

Sanction has therefore been accorded by the Vice-Chancellor, exercising the power under Section 3.10(17) of the MGU Act 1985 to rectify the errors and to release the balance amount due to the above mentioned teachers. Accordingly the entry at Sl. Nos. 40, Paragraph 17(a) of the said U.O. is rectified as follows.
