ORDER

1. Mahatma Gandhi University was established by the Kerala State Legislature by Act 12 of 1985(Notification No.3431/Leg.CI/85/Law dated 17.04.1985) and as per the Mahatma Gandhi University Statutes 1997 issued thereunder, the University has 18 statutory Schools/Departments of study/research wherein there are Govt. sanctioned posts of permanent teachers. Apart from the above statutory Schools/Departments, the University had established Self-financing institutions taking into account the then prevailing circumstances to provide instruction in certain job oriented courses in self-financing mode and for that purpose teaching and non-teaching Staff were engaged. Unlike the Statutory departments of the University, these institutions were not established in accordance with the provisions contained in the Statutes of the University. These self financing institutions were managed and run by the University and operated wholly on the funds generated from those institutions by way of tuition fees from the students, without any financial aid either from the State

Government or from the UGC towards the expenses of salaries and allowances of the teachers and non-teaching staff and infrastructural development.

2. In the above factual premise, all appointments/ engagements to these Self-financing institutions were done on three different modes ie temporary on scale of pay, contract on consolidated remuneration and Guest teachers. For running these self-financing institutions, core faculty members with prescribed UGC or AICTE qualifications were appointed temporarily on scale of pay. Thus, all the engagements in the self-financing institutions were on temporary basis. The engagements in these self-financing institutions were done on temporary basis as the very existence of these self-financing institutions was depended upon the financial viability of the courses/institutions. The University later framed the Special Rules incorporating provisions for the conditions of service and method of appointment for the teachers and non-teaching staff of these self-financing institutions. As per the above Special Rules, all orders issued by the University inconsistent with the Special Rules were superseded.

3. The Government vide G.O.(MS) No. 97/2013/H & FWD dated. 22.03.2013 directed the University to affiliate Health related courses to Kerala University of Health and Allied Sciences and informed that if this is not done the courses will not be approved henceforth. This was brought before the attention of the Government of Kerala. At a meeting held on 22.01.2017 with the Minister for Health and Minister for Education, Government of Kerala, it was resolved to form a separate entity to conduct the Health related courses offered by Mahatma Gandhi University which can be affiliated to Kerala University of Health and Allied Sciences, since the relevant Act of Kerala University of Health and Allied Sciences forbids any other University in Kerala from conducting Health related courses. In pursuance to the above, the Syndicate at its meeting held on 25.02.2017 resolved that the University would not directly conduct any Self Financing courses/Institutions from the academic year 2017-18.

4. Vide G.O.(MS) No.101/2017/H.Edn dated. 06.04.2017, the Government of Kerala approved the Memorandum of Association, and the Rules and Regulations for the establishment, function etc. of a Society named the "Centre for Professional and Advanced Studies" for the co-ordination, management and administration of all Self Financing Institutions run by the Mahatma Gandhi University. Accordingly The Society namely "Centre for Professional and Advanced Studies"(CPAS) has been established and registered. The teachers and non-teaching staff of the self financing institutions formerly managed by the University were also permitted to be continued subject to the terms and conditions as specified in clause 9 of the Agreement signed between the Society and the University. The Standing Committee of the Academic council of the University at its meeting held on 13-07-2017 recommended to discontinue the engagement of teaching and other staff in the Self Financing Institutions previously run by the University. The above recommendation was approved by the Vice-Chancellor exercising the powers under section 10(17) of the Mahatma Gandhi University Act, 1985. The Syndicate of the University at its meeting held on 17.07.2017 resolved to accept the same.

5. Considering the requests submitted by Dr.Joji J Anchanattu, Dr. Eldhose N V and S.Krishnakumar, lecturers appointed on contract basis in the School of Technology and Applied Sciences, the Syndicate of the University resolved to grant them scale of pay of Rs.8000-275-13 on the following grounds:

(a) they had completed 8 years of service out of which 4 1/2 years continuous service in School of Technology and Applied Sciences.

(b) the incumbents were on the brim of overage.

(c) they were qualified as per UGC/AICTE norms.

The scale of pay was effected from 1-01-2002 as long as course/institution in which they were working stands financially viable. Subsequent to the grant of scale of pay to the above 3 teachers, Sri P V Anilkumar, another lecturer in STAS put forth his claim for the benefits granted to these teachers claiming that he was similarly placed to the above lecturers. Considering this, he was also placed in the scale of pay wef 01.01.2002 as per the University order dated 20-10-2006.

6. When Sri P V Anilkumar was placed in the scale of pay as stated above, relying on that order Smt. Bijamma Thomas, another lecturer in STAS submitted a representation before the University to grant scale of pay to her as she was senior to Sri PV Anilkumar. Smt Bijamma Thomas was originally engaged as Lecturer in Operations Research on contract basis in the School of Applicable Mathematics, a Self-financing institution which was later wound up and her engagement was dispensed with accordingly. Later, on the basis of a representation submitted by her, the Syndicate had resolved to engage her on compassionate grounds as lecturer in Mathematics in the School of Technology and Applied Sciences on contract basis without any selection process and an agreement was also executed by her. The terms and conditions specified in the agreement was extended further on the basis of her request. Her request for scale of pay was rejected by the University and subsequently WP (C) No 1499/2009 was filed by her before the Hon'ble High Court of Kerala seeking similar benefits granted to Sri P V Anilkumar contending that she was senior to him when the total years of service put in by her in the two institutions were taken together. The Hon'ble High Court of Kerala allowed the Writ Petition against which the University filed Writ Appeal No 1709/2009. The Division Bench of the Hon'ble High Court of Kerala dismissed the writ Appeal filed by the University. Aggrieved by the aforesaid judgment of the Hon'ble High Court, Special leave petition was filed before the Hon'ble Supreme Court and the same was dismissed at the stage of admission itself. Consequently she was placed in the scale of pay of Rs.8000-275-13500.

7. On the basis of the complaints received by the University against the grant of scale of pay to these lecturers who were initially appointed on contract for a consolidated pay, the matter was enquired by a committee appointed by the Syndicate. After hearing all those contract lectures, the committee submitted a report. In the report it was found that grant of scale of Pay to contract employees who were not appointed against regular sanctioned posts and are governed by the terms and conditions of the bond executed by them was a mistake. The report was accepted by the Syndicate and accordingly the scale of pay given to the teachers appointed on contract basis was withdrawn.

8. Among the judgements read as (1) above, in WP (C) No. 19540/2009, 19795/2009, 19852/2009, 20095/2009, 20160/2009, 20304/2009, 20400/2009, 20402/2009, 20736/2009, 20961/2009, 23640/2009, 17517/2010, 2311/2011, and 18041/2011, the petitioners who were working as lecturers on contract in the various Self Financing Institutions formerly run by the University had sought relief to grant Scale of Pay and other benefits to them. The single bench of the Hon'ble High Court of Kerala as per Common Judgment dated 2-01-2013 has directed the University to give the same benefits granted to the petitioner in WP(C) 1499/2009, wherein the petitioner Smt. Bijamma Thomas was granted consequential benefits placing her in the scale of pay of Rs.8000-275-13500 wef 1-01-2002 after counting her total service of 6 years and 11 months from the date of her initial contract service as qualifying service.

9. In WP (C) 1930/2013 which was filed by Sri.Abdul Muhammed Rasheed and 8 others praying for grant of scale of pay and other consequential reliefs, the learned Single Judge vide order dated 23-1-2013 relied upon the judgement in WP (C) 1499/2009 (Smt. Bijamma Thomas) and ordered to extend the benefits granted to Bijamma Thomas by placing the petitioners therein in the scale of pay.

10. W.P.(C) 20680/2009 was filed by Sri.P.V.Anilkumar wherein the challenge pertains to withdrawal of the grant of scale of pay and refusal of declaration of probation. The Learned Single Judge by judgment dtd.2.1.2010 quashed Exts.P11, P12 , P13 and P14 thereby restoring the scale of pay and other benefits granted to him vide Ext.P6 the University order granting scale of pay to the petitioner. It was further directed that the arrears of salary have to be paid and declare his probation w e f 2.1.2003 as in the case of Dr. Joji J Anchanattu, Dr. S.Krishnakumar and Dr.N.V.Eldhose by counting his service. The claim for senior scale will also be considered accordingly.

11. WP(C) 20060/2009 was filed by Sri.Regiram and Sri.Suresh S. The nature of relief sought was for grant of scale of pay. The Writ Petition has been disposed of directing the University to consider the representation of the petitioners (Ext.P5,P6 and P7) in the light of the dictum in WP(C).20680/2009 filed by Sri.P.V.Anilkumar.

12.WP.(C)30354/2012 was filed by Smt.Suja Mathews claiming scale of pay, relying on Ext.P11 judgment in WP(C).20680/09 filed by Sri.P.V.Anilkumar and Ext.P12 judgment in WP(C).1499/2009 filed by Smt.Bijamma Thomas and Ext.P13 Writ Appeal No.1709/09 and Ext.P15 judgment in WP.(C) 20060/09. The Learned Single Judge disposed of the said Writ petition vide judgment dtd.15.2.2011 directing the Vice Chancellor of the University to consider Ext.P16 request of the petitioner in the light of Ext.P11, P12 and P13 judgments and applying the dictum in 20060/2009.

13. In WP(C) 25493/2011 filed by Smt. Sagi T.M. the relief sought for was to regularise and grant scale of pay approved by AICTE. The Learned Single Judge by judgment dtd.8.12.2013 directed the University to regularize the petitioner in service, to declare her probation and to consider her claim for senior scale. It was also directed to consider the petitioner's claim for regularization as Assistant Professor in the Head of the Department of Medical Laboratory Technology and to take appropriate decision in the matter having regard to exhibit P9, P10 and P11 judgements of the Hon. High Court in W.P.(c). 1499/2009, 20680/2009 and W.P.(c). 20060 of 2009 respectively.

14. WP(c).2148/2011 was filed by Dr.Joji.J.Anchanattu, Dr.S.Krihsnakumar, and Dr.N.V.Eldhos wherein the challenge was withdrawal of scale of pay and consequential benefits granted to them. The said Writ petition was decided along with the batch of writ appeals and it was directed to restore all the benefits which were granted to them.

15. As per the order dated 21.08.2017 read as (5) above, the Hon'ble High Court issued directions to the University to fully comply with the judgements read (1) above before 29.08.2017. In compliance with the directions contained in the judgements, the University issued order dated 24.08.2017 read as (6) above granting scale of pay and other consequential benefits as ordered by the Hon. High Court of Kerala. For calculation of arrears of salary a special cell was constituted and as an interim measure, an amount of Rs. 5,00,000/- was paid to the petitioners and balance amount was ordered to be paid in lump sum as and when the report of the Special Cell was received.

16. As per the order dated 29.08.2017 read (7) above ,the Hon'ble High Court of Kerala observed that the order issued by the University read (6) above was not in full compliance of the

directions issued by the Hon'ble Court and further directed the University to fully comply with the directions of the Hon'ble Court before 20.09.2017.

17. Hence the matter was placed before the meeting of the Syndicate held on 16.09.2017. The Syndicate as per the resolution read as (8) above resolved in full compliance of the directions of the Hon'ble high Court of Kerala that;

(a) The petitioners in WP (c) Nos. 19540/2009, 19795/2009, 19852/2009, 20095/2009, 20160/2009, 20304/2009, 20400/2009, 20402/2009, 20736/2009, 20961/2009, 23640/2009, 17517/2010, 2311/2011, 18041/2011 being granted the same benefits given to the petitioner in WP(c) 1499/2009 as stated in paragraph 8 above by placing them in the scale of pay of Rs.8000-275-13500 and other consequential benefits as per the details given below:

Also considered her claim for regularization as Assistant Professor in the Head of the Department of Medical Laboratory Technology and resolved that she is deemed to have been regularized as Assistant Professor in the Head of the Department of MLT, School of Medical Education.

(g) the benefit of scale of pay and other consequential benefits given to the petitioners in WP(c) 2148/2011 namely Dr. Joji J Anchanattu, Dr.S Krishnakumar and Dr.N V Eldhose being restored.

The Syndicate also considered the directions of the Hon'ble High Court of Kerala with regard to the granting of senior scale to the petitioners in WP (c) Nos.20680/2009, 20060/2009, 30354/2012 and 25493/2011 and resolved to grant senior scale to the petitioners namely (1) Sri. Anilkumar P V (2) Sri. Regiram S (3) Sri. Suresh S (4) Smt. Sagi T M and (5) Smt. Suja Mathews. It was further resolved to direct the above 5 petitioners to produce necessary certificates and documents for effecting the same.

Further resolved to ensure the following aspects in the disbursal of arrears and other benefits.

- The entire amount due to the petitioners in the above writ petitions are given after deducting Rs. 5,00,000/- which was paid to the petitioners vide reference (6) above as an interim measure and also effecting statutory deductions.
- Excess amount if any received by any of the petitioners over and above the eligible amount as ordered by the Honorable Court, shall liable to be refunded.
- The increments should be included in the scale of pay, declaration of probation is to be made in all eligible cases.
- Granting of arrears to the petitioners is in full compliance of the judgments of the Hon'ble High Court of Kerala and the same will in no way be deemed to confer any right for further claims in future.
- The directions passed by the Hon'ble Court is fully complied with in its true letter and spirit.

The details of arrears of salary paid to all the petitioners above mentioned are appended herewith as Annexure to this order.

The petitioners shall be paid arrears of salary upto the month of June 2017. Since the self financing institutions formerly run by the University, in which the above mentioned petitioners were working, have been transferred under the management of the Centre for Professional and Advanced Studies as per the Agreement signed between the Society and the University and since the University ceased to be their employer, the Director CPAS shall be requested to take all further necessary steps.

Further resolved to authorize the Vice Chancellor to sanction the amount due to the petitioners on the recommendation of the Finance Officer and the Finance Officer shall disburse the amount to the petitioners forthwith

Orders are issued accordingly.
