Hon'ble High Court of Kerala has issued a writ of quo warranto in WP(c) No 33445/2017 against the continuance of Dr. Babu Sebastian as Vice Chancellor of Mahatma Gandhi University, resulting in a temporary vacancy in the office of the Vice Chancellor.

In the circumstances, the Chancellor of Mahatma Gandhi University, in exercise of the powers conferred by Section 10(24) of Mahatma Gandhi University Act 1985 has ordered that Dr.Sabu Thomas, senior most Professor of the University shall exercise the powers and perform the duties of the Vice Chancellor, Mahatma Gandhi University with effect from 20.02.2018, in addition to his normal duties, until further orders.

Accordingly, Dr.Sabu Thomas, Professor, School of Chemical Sciences has assumed charge as Vice Chancellor of Mahatma Gandhi University with effect from the FN of 21.02.2018.

Hence it is hereby notified that Dr.Sabu Thomas, Professor, School of Chemical Sciences shall exercise the powers and perform the duties of the Vice Chancellor, Mahatma Gandhi University with effect from the FN of 21.02.2018, in addition to his normal duties, until further orders.
