An Institution seeking recognition requires the following provisions:

- 1. Shall conform to the standards, aims and objectives of the University and its programmes of teaching and Research.
- 2. Shall be a reputed academic/scientific Institution or an affiliated college with PG department in the concerned subject. No. Institution shall be recognised as a Research Centre if the subject disciplines or inter disciplinary areas in which it seeks recognition do not fall under any of the faculties mentioned in the Statutes.
- 3. Shall be housed in its own building with all facilities for research.
- 4. Must have two staff members with phD degree, two year post doctoral experience and atleast two publications in reputed academic journals. Their Doctorate Degree shall be from universities recognised by the UGC or from well-known universities abroad. The filled in applications of two qualified staff members for recognition as research guides should be submitted along with the application for recognition as research centre.
- 5. Shall have its own library, with minimum 5000 original books (text books/popular books shall not be counted) in the area of research and subscribed to at least 10 journals of National and International standard. Internet facilities are desirable.
- 6. Shall have a laboratory adequately equipped.
- 7. DD/Pay-in-slip worth Rs. 2000/- for institutions comes under the jurisdiction of the University and Rs. 4000/- for other institutions towards fee for recognition should be attached along with the application
