ADMISSION NOTIFICATION

Applications are invited for admission to the 5 Year BBA LLB (Hons) Programme of the School of Indian Legal Thought, Mahatma Gandhi University, Suryakalady Hills, Nattasserry, S.H. Mount P.O., Kottayam – 686 006, Kerala, for the academic year 2018-19.

The details of the Programme and eligibility conditions are as follows:

The candidate should be below 20 years of age as on 1 st July of the year concerned.	Higher Secondary or +2 Examination recognized by Mahatma Gandhi University or any other examination recognized as equivalent thereto with not less than 45% marks in aggregate. The candidate should be below 21 years of age as on 1 st July of the year concerned.	30

SELECTION PROCESS:

Selection of students is based on the marks secured in the Entrance Test. The Entrance Test shall be of 2 hours duration carrying 100 marks and is intended to test the General Knowledge, Logical Reasoning, Language skills etc of the candidates.

The applicants who have obtained 10+2 or graduation through Open University System directly without having any basic qualifications for prosecuting such studies are not eligible for admission to law programmes.

Documents to be attached to the application

- Self attested copies of documents to prove qualification/age/caste and other relevant certificates should be attached along with the application. Original documents should be produced at the time of interview/admission.
- Those who have qualified from Boards (excluding CBSE, ICSE) outside Kerala State should produce eligibility/recognition certificate from this University and those who have qualified from Boards (including CBSE, ICSE) should produce Migration Certificate from parent Board at the time of admission.

RESERVATION OF SEATS:

Three percent of total seats are reserved for candidates having physical disabilities and the remaining seats shall be considered for implementing mandatory reservation. Physically challenged candidates suffering from disability of 40% or more and certified as such by a Government Medical Board indicating the percentage of disability shall be considered for reservation.

COMMUNAL RESERVATION:

The reservation will be given as per Government norms.

WEIGHTAGE OF MARKS

Weightage of marks for proficiency in Sports/Games/NCC/NSS etc. and bonus marks for Ex-servicemen applicants and widows and children of Jawans/ Ex-servicemen will be given as per the existing rules of admission.

GENERAL CONDITIONS

- a) All those who possess the approved minimum qualification are eligible to apply.
- b) Only the Programmes and their equivalents approved by the Mahatma Gandhi University shall be reckoned as eligible qualification.
- c) CANDIDATES AWAITING FINAL YEAR RESULTS CAN ALSO APPLY FOR THIS PROGRAMME, PROVIDED THEY PRODUCE THEIR MARKLISTS AT THE TIME OF ADMISSION.
- d) No rounding of percentage of marks to the nearest whole number is permitted.

If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she had indulged in ragging, admissions shall be refused or he/she shall be expelled from the educational institution.

The Hon'ble Supreme Court of India has directed that if any incident of ragging comes to the notice of the authority, the student concerned shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the institution.

HOW TO APPLY:

- a. Application forms can be downloaded from the Website www.mgu.ac.in. Application forms are not available at any other source.
- b. Candidates should remit the REGISTRATION FEE of Rs. 660/- through online payment mode available in the University website.
- c. SC/ST candidates need to pay only 50% of the registration fee.
- d. Fee once remitted shall not be refunded.
- e. The University will not be responsible for delay in communication or late receipt of any document due to postal delay.


- f. The filled up application form should be complete in all respects. Defective and incomplete applications will be summarily rejected.
- g.
