ADMISSION NOTIFICATION

Applications are invited for admission to the MBA Programme offered at the School of Management and Business Studies, for the Academic year 2018-'19.

Duration of the course	2 years (4 semesters)
Student Intake	60
Eligibility	A pass in any Bachelor's Degree Examinatyion of Mahatma Gandhi University or an equivalent degree of any other Universities duly recognized by Mahatma Gandhi University with not less than 50% marks in aggregate for all parts of examinations OR Masters Degree in any subject. Only a pass in the qualifying exam is required for SC/ST candidates. Those who are awaiting final semester results of qualifying exam can also apply provided that they should produce certificates and marklists of qualifying exam before the commencement of their first semester MBA examination. Candidates should have valid CMAT/CAT/ KMAT score. Relaxation of marks and reservation of seats are based on University/Govt. rules.

SELECTION PROCESS:

Selection of students is based on the score obtained in CMAT/CAT/KMAT, Group Discussion and personal interview in the ratio 80:10:10.

ELIGIBILITY CONDITIONS:

- a. Copies of documents to prove Qualification/Age/Caste/Score Card received from CMAT/CAT/KMAT and other relevant certificates should be attached along with the application. Original Certificates should be produced at the time of interview/admission. Those who have appeared for final examination can also apply.
- b. Those who have qualified from Universities other than Mahatma Gandhi University should produce Eligibility/Recognition Certificate from this University and Migration Certificate/NOC from parent University at the time of admission.

RELAXATION OF MARKS AND RESERVATION OF SEATS:

Only a pass in the qualifying exam is required for SC/ST candidates. SEBC candidates are eligible for a concession of 3% marks and OEC candidates are eligible for a concession of 5% marks. In the absence of SC/ST candidates, vacancy will be filled up by admitting eligible OEC

candidates. Three percent of seats shall be reserved for candidates having physical disabilities. Physically challenged candidates suffering from disability of 40% or more and certified as such by a Government Medical Board indicating the percentage of disability shall be considered for reservation.

COMMUNAL RESERVATION:

The percentage break up of seats as per mandatory reservation norms based on University/Government rules is as follows.

Economically backward among forward community should invariably submit income certificate from Village Officer and BPL Certificate from the authority concerned in proof of their eligibility.

Reservation of seats to the SEBC will be in accordance with the provisions contained in G.O.(P) 208/66/Edn. dated 02.05.1966, as amended from time to time. Candidates claiming reservation under SEBC Quota should invariably produce both 'Community' and 'Non-Creamy Layer' Certificates obtained from the Revenue authorities concerned. The self attested copies of the above certificates should be attached with the application.

Reservation and relaxation in minimum marks based on income, caste etc. will be allowed according to the rules of the University.

If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she had indulged in ragging, admissions shall be refused or he/she shall be expelled from the educational institution.

The Hon'ble Supreme Court of India has directed that if any incident of ragging comes to the notice of the authority, the student concerned shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the institution.

HOW TO APPLY:

- a. Application forms can be downloaded from the Website www.mgu.ac.in. Application forms are not available at any other source.
- b. The Registration Fee for MBA programme is **Rs.880/-.** Candidates should remit the **REGISTRATION** fee by way of **e-payment**.
- c. SC/ST candidates need to pay only 50% of the registration fee.
- d. Fee once remitted shall not be refunded.
- e. The University will not be responsible for delay in communication or late receipt of any document due to postal delay.
- f. The filled up application form should be complete in all respects. Defective and incomplete applications will be rejected.
- g. Duly filled up applications along with Registration Fee (e-payment receipt) and a self addressed stamped (Rs. 5/-) envelope should be forwarded to the Director, School of Management and Business Studies, Mahatma Gandhi University, Priyadarsini Hills P.O., Kottayam 686 560, Kerala. Last date for receipt of filled up application forms is 20.04.2018.
