ORDER

The Sub Committee on MGU – CSS – PG – 2011 held on 21 November 2011 has recommended to effect the following modifications in the wake of the discussions held with the Chairpersons / Conveners of various Board of Studies / Expert Committee held on 16 November 2011, in the PG Programme Regulations for Credit Semester System 2011, introduced as per U.O. read (1) above.

To Add the following:-

After Clause 3.5

- 3.5 (a) 'Academic Week' is a unit of five working days in which distribution of work is organized from day one to day five, with five contact hours of one hour duration in each day. A sequence of 18 such academic week constitute a Semester.
- 3.5(b) 'Zero Semester' means a Semester in which a student is permitted to opt out due to unforeseen, genuine reasons.

After Clause 3.27

3.27(a) Extra Credits' are additional credits awarded to a student over and above the minimum credits required for a programme for achievements in co-curricular activities carried out outside the regular class hours, as decided by the University.

After Clause 3.29

3.29(a): 'Weighted Grade Point Average' '(WGPA)' is an index of the performance of a student in a course. It is obtained by dividing the sum of the weighted grade points by the sum of the weights of the grade points. WGPA shall be obtained for CE and ESE separately and then the combined WGPA shall be obtained for each course.

Clause 8. REGISTRATION shall be modified as follows:

8. REGISTRATION/DURATION

- 8.1. The duration of P.G. Programmes shall be 4 semesters.
- 8.2. The duration of each semester shall be 90 working days. Odd semesters from June to October and even semesters from December to April. There will be one month semester breaks each in November and May.
- 8.3. A student may be permitted to complete the Programme, on valid reasons, within a period of 8 continuous semesters from the date of commencement of the first semester of the programme.

Clause 13.3 shall be modified as follows.

Clause 13.12 shall be modified as follows.

Clause 13.12.

The overall grade for a programme for certification shall be based on CGPA with a 7 point scale as given below:

CGPA	Grade
3.80 to 4.00	A +
3.50 to 3.79	A
3.00 to 3.49	B +
2.50 to 2.99	В
2.00 to 2.49	C +
1.50 to 1.99	С
1.00 to 1.49	D

A separate minimum of C Grade for Internal and External are required for a pass for a course. For a pass in a programme a separate minimum Grade C is required for all the courses and must score a minimum CGPA of 1.50 or an overall grade of C and above.

The following line shall be added to Clause 13.15

There will be no supplementary examinations.

In Clause 13.16, the SGPA of 2.00 shall be modified as SGPA 1.50.

After Clause 13.16, the following shall be added

13.17. PATTERN OF QUESTIONS:

Questions shall be set to assess knowledge acquired, standard application of knowledge, application of knowledge in new situations, critical evaluation of knowledge and the ability to synthesize knowledge. The question setter shall ensure that questions covering all skills are set. He/She shall also submit a detailed scheme of evaluation along with the question paper. A question paper shall be a judicious mix of short answer type, short essay type / problem solving type and long essay type questions.

Weight: Different types of questions shall be given different weights to quantify their range as follows:

In sub clause (1) of the models of distribution of course and credit given after Clause 19 of the Regulations, shall be substituted as "Total credit of the programme shall be 80".

A. Consolidation of Grades for Internal Evaluation :

If B.C,B and A grades are scored by a student for attendance, assignment, seminar and test paper respectively for a particular course, then her/his CE grade for that course shall be consolidated as follows:

B. Consolidation of Grades for External (one Answer Paper – Theory)

The grade of a answer paper (ESE Practical) shall be consolidated by similar procedure discussed above by assigning weights for the various components (e.g., Procedure, Experiment, Calculation, accuracy of the reported values, Presentation of results, Diagrams, etc.) The Boards of Studies shall define the components and their weights and include them in the scheme and syllabus of each practical course.

Calculation: Overall grade of an answer paper = sum of weighted grade points / sum of the weightage = 73/30 = 2.43 = Grade C

C. Consolidation of the Grade of a Course : The grade for a course is consolidated by combining the ESE and CE grades taking care of their weights.

For a particular course, if the grades scored by a student is C and B respectively for the External and Continuous Evaluation, as shown in the above examples, then, the grade for the course shall be consolidated as follows:

D. Consolidation of SGPA

SGPA is obtained by dividing the sum of credit points (P) obtained in a semester by the sum of credits (C) taken in that semester. After the successful completion of a semester, Semester Grade Point Average (SGPA) of a student in that semester shall be calculated using the formula given. Suppose the student has taken three courses each of 4 credits and two courses each of 2 credits in a particular semester. After consolidating the Grade for each course as demonstrated above, SGPA has to be consolidated as shown below:
