In exercise of the powers conferred by Section 23(ii) of the Mahatma Gandhi University Act, 1985, the Syndicate of the University at its meeting held on 12.01.2018 (item no.80/18.01/172422) has passed the following amendments to the Mahatma Gandhi University Statutes, 1997.

Amendment to Mahatma Gandhi University Statutes, 1997

In the said Statutes: - in
Statue 1 in Chapter 11

Item no.17

17. "The other faculties as may be instituted by the University from time to time not inconsistent with the provision of the Act" **shall be replaced by:-**

17. "The Faculty of Tourism and Hospitality Studies"

AND

In the Statutes 1 in Chapter 11 the following **shall be incorporated** as item no.18.

18. "The other faculties as may be instituted by the University from time to time not inconsistent with the provision of the Act"

The above statutes, as amended, read as follows:-


Chapter/Statute	Amended Statute

Chapter 11, FACULTIES Statute 1	18. The other faculties as may be instituted by the University from time to time not inconsistent with the provision of the Act.

These amendments have been assented to by the Hon'ble Chancellor on 28.06.2018 as intimated by the Secretary to Governor vide his letter No. GS5-809/2018 dated 28.06.2018. The above amendments shall come into force from 2018-2019 academic year.
