### ORDER

Smt. Lakshmisree R, scholar who got registration for research in 2013 Admission, has requested, vide the paper cited (1), to extend the time limit to complete the research, for six more months. As per the U.O. read as (2) above, her period of research expires on 31.12.2018.

The scholars registered, irrespective of full time or part time mode, and have got registration in 2012 admission or prior to 2012 admission, under the guidance of retired/adjunct/deputation/transferred category of supervising teachers, were granted, vide the paper cited (3), extension of time limit from 31.07.2018 to 31.12.2018, for completing the research work.

As per the U.O. read as (4) above, the scholars in research centres coming under the jurisdiction of other universities or self financing research centres were permitted to complete their work and submit the theses by 31.07.2019.

Having considered all the above, the Professor in charge of the Vice-Chancellor, by exercising powers under section 3.10(17) of Mahatma Gandhi University Act, 1985, has accorded sanction to extend the period of research upto 31.07.2019, to all research scholars registered, irrespective of full time or part time mode, under the guidance of retired/adjunct/deputation/transferred category of supervising teachers and whose time limit was fixed at 31.12.2018, vide the U.O.s cited (2) and (3).

For the extension of the research period, the research scholars have to apply for the same by remitting the required fee, fixed by the University from time to time.
