## ORDER

The Government has sanctioned vide G.O read (1) above to start M Sc Cyber Forensic programme (20 seats) in STAS Pathanamthitta , the Regional Centre under the control of Centre for Professional and Advanced Studies(CPAS), Gandhinagar, Kottayam during the academic Year 2018-19.

As per reference (2) the Director, Centre for Professional and Advanced Studies, the educational Agency, has submitted the application for affiliation of above mentioned programme during the academic Year 2018-19 after the statutory date for consideration, following the issuance of Govt Order dated 03/09/2018.

As per section 58(2)of Mahatma Gandhi University Act 1985, late applications can be considered by the Syndicate ,provided the Hon'ble Chancellor by notification in the Gazette extends the period within which the Syndicate shall consider such applications for affiliation of new courses/College.

The application for affiliation submitted on 06/09/2018 by The Director, Centre for Professional and Advanced Studies was placed before the Syndicate. As per reference(3)above, the syndicate sub committee on affiliation has resolved to recommend to seek Hon. Chancellor's permission to extend the time for considering the belated applications. The Professor in charge of the Vice Chancellor, In exercise of the Powers under section 3.10(17)of MGU Act 1985, considered the above recommendation and decided to request the Hon. Chancellor to extend the time limit for considering the application up to 15/11/2018.

As per reference No.(4)permission has been granted by the Hon'ble Chancellor to the syndicate to consider the said application in accordance with the provisions of the University Act and statutes within the time limit ie, up to 15<sup>th</sup> November 2018.

Inspection Commission was constituted vide paper read (5) above ,to assess the instructional and infrastructural facilities available with the above mentioned college for the affiliation of the new Course Viz. M Sc Cyber Forensic (20 seats) in School of Technology & Applied Science in Pathanamthitta.

As the Commission is satisfied as to the infrastructure and academic facilities available in the College for starting the new programme M Sc (Cyber Forensic) in STAS Chuttippara, Pathanamthitta under CPAS, the commission recommends to grand affiliation to M Sc (Cyber Forensic) STAS, Pathanamthitta under CPAS for the academic year 2018-19.

On the basis of the report submitted by the Inspection Commission concerned, the Professor in charge of the Vice Chancellor, In exercise of the Powers under section 3.10(17)of MGU Act 1985 by the order dated 15.11.2018 has approved the recommendation of the inspection commission and permitted to start the programme as per the Government rules and regulations during the academic year 2018-19.

Therefore, Provisional affiliation is granted to M Sc (Cyber Forensic) of STAS Pathanamthitta during 2018-19 as detailed below.

Provisional affiliation is granted subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one academic year only
- 2. The College shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. As per U O read (6) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the educational agency on the basis of merit.

- b) Students insurance premium @ Rs. 23/- per student per year.
- c) Students Welfare Fund @ Rs. 30/- per student per year.
- d) University Union Fee @ Rs. 50/- per student per year.
- e) Sports Affiliation fee @ Rs. 200/- per student per year to be utilized in the ratio @ 50:50 by the University and the College.
- f) Collection of Annual Administration fee from the students under any circumstances is not permitted.
- g) Students affiliation fee @ Rs.650/-for P.G course collected on one time basis from all students shall be remitted to the University within fifteen days after closing of the admission.
- 5. The educational agency shall remit the course affiliation fee as detailed at 4(a) above.
- 6. The College shall collect tuition fee as decided by the University.
- 7. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college. The Principal of the college shall endorse the undertaking.
- 8. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
- 9. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any notice.

Orders are issued accordingly.
