ORDER

As per paper read (1) above, the notification for appointment to the post of Associate Professors in University Departments was issued.

The Selection Committee held on 26.06.2018 for the post of Associate Professor in School of Social Sciences recommended Dr. Abhilash Babu to be appointed as Associate Professor (SC Category) in the School of Social Sciences. The Syndicate vide minutes read as paper (2) above resolved to approve the proceedings of the Selection Committee held on 26.06.2018 for the Selection of Associate Professors in the School of Social Sciences. As per the judgement vide paper (3) on WP(C) No. 22540 of 2018 filed by Dr. Rajesh Komath, a candidate for the interview, the Hon'ble High Court of Kerala passed judgement as "Setting aside the selection of the 4th respondent (Dr Abhilash Babu), the writ petition is disposed of directing the selection committee to rework the selection".

Accordingly, the Syndicate vide paper (4) above entrusted the Vice Chancellor to decide upon the further course of action in the matter. The meeting of the Selection Committee held on 29.01.2019 to rework the Selection, found that there was no omission or discrepancy in the scores awarded to Dr.Rajesh Komath and Dr.Abhilash Babu. Therefore, the Selection Committee resolved that the ranking made by the Committee on 26th July 2018 for the post of Associate Professor (SC Category) stands valid and the criteria requires no revision as it is made in accordance with the UGC Rules and Regulations.

The Syndicate vide paper (5) resolved to approve the proceedings of the Selection Committee constituted to rework the selection of Associate Professor in the School of Social Sciences convened on 29.01.2019, as per the directions of the Hon'ble High Court of Kerala in WP(C) No. 22540 of 2018 and to approve the recommendations of the Selection Committee. The Syndicate resolved also that the appointment to the above post will be made after getting concurrence of the Election Commission.

Orders are issued accordingly.
