**ORDER**

The applications submitted by the Director, CPAS , vide paper read (1) above, for starting New programmes in School of Technology & Applied Sciences, Pullarikkunnu, during the academic year 2019-20, were considered by the Syndicate Sub committee on affiliation and resolved to recommend to seek Hon'ble Chancellor's permission to extend the time for considering the belated applications upto 30.07.2019, and Inspection Commissions were constituted vide ref (2) above, to assess the instructional and infrastructural facilities provided by the Educational agency to start the proposed Programme. The recommendations of the Commission were forwarded for the views of Government of Kerala vide paper read (3) & (4) above. The Government of Kerala vide paper (5) above accorded administrative sanction for starting new Programme M.Sc. Cyber Forensic in School of Technology & Applied Sciences, Pullarikkunnu during the academic year 2019-20.

As per reference (6) permission has been granted by the Hon'ble Chancellor to the Syndicate to consider the said application in accordance with the provisions of the University Act and Statutes within the time limit.

Sanction has therefore been accorded by the Vice-Chancellor u/s 3.10(17) of the M G University Act, 1985 to School of Technology & Applied Sciences, Pullarikkunnu for new programme M.Sc Cyber Forensic (20) seats, subject to the verification of the compliance of Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty, qualifications etc.

As University has already completed admissions vide CAP for 2019-20 academic year, the following college is hereby entrusted to have spot admission in 2019-20 academic year only, observing rules and regulations and reservation principles envisaged by University and Government of Kerala and the following programme shall be included in CAP for admissions from 2020-21 academic year onwards.

Provisional affiliation to the above mentioned permanent seat increase is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one academic year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
3. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the educational agency on the basis of merit.

- b) Students insurance premium @ Rs.23/- per student per year.
  - c) Students welfare fund @ Rs. 30/- per student per year.
  - d) University union fee @ Rs. 50/- per student per year.
  - e) Sports affiliation fee @ Rs. 300/- per student per year to be utilized in the ratio @ 200:100 by the university and the college
  - f) The collection of annual administration fee from the students under any circumstances is not permitted.
  - g) Student's affiliation fee @ Rs. 550 & 750 /- for UG & PG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing of the admission.
5. The rate of Tuition Fee as per University and Government orders issued time to time.
  6. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time in so far as they are related to the college. The Principal of the college shall endorse the undertaking.
  7. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
  8. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any notice.
