**ADMISSION TO M.A.SOCIAL WORK IN DISABILITY STUDIES AND ACTION
(M.A.SWDS) PROGRAMME 2019-20**

Applications are invited for admission to the M.A. Social Work in Disability Studies and Action Programme (*Approved by Rehabilitation Council of India, New Delhi*) at the School of Behavioural Sciences for the academic year 2019-20.

Duration of the Programme: Two Years (Four semesters)

Intake of students: 20 (Twenty only)

Eligibility for Admission: candidates who have passed graduate level degree examination in any Arts subject with not less than 45% marks or equivalent grade, or in any Science subject with a minimum of 50 % marks or equivalent grade, which is recognized by Mahatma Gandhi University are eligible for admission to the M.A. Social Work in Disability Studies and Action Programme. Preference will be given to those applicants who have some experience in the field of disability.

Admission Procedure: The candidates shall be selected for admission from the rank list prepared on the basis of the following criteria.

Written test : 100 marks – Syllabus- General knowledge, Indian society, economy and polity and comprehension ability.

Personal Interview: 100 Marks

Total Marks: 200

General reservation rules applicable for admission to post graduate degree programme at the regular University Departments shall be followed while admitting candidates from the rank list.

Date & Time of Written Test: 17th September 2019, 10.30 am to 12.30 pm.

Date of Interview: 19th September 2019

Centre for Written Test: School of Behavioural Sciences, Mahatma Gandhi University.

2. Last date of receipt of filled up application form along with Registration fee is 06th September 2019.

3. The Registration fee is Rs.1000/-for General Candidates & Rs 500/- for SC/ST candidates. Candidates shall remit the registration fee through MGU online payment gateway.
4. Candidates awaiting final year results of the qualifying examination can also apply, provided they produce mark lists of the qualifying examination on or before the last date for the same as instructed by the University.
5. Reservation, relaxation in minimum marks based on income, caste, etc. will be allowed according to the rules of the University.
6. The programme will be conducted under Credit and Semester System.
