### <u>ORDER</u>

The University Grants Commission has sanctioned financial assistance under NSQF to start new B Voc Courses in various aided arts & science colleges for the academic year 2018-19. Accordingly, the applications submitted by the Principals & Managers of aided colleges vide paper (1) read above, for starting new B Voc Courses were considered by the University after getting permission of the Hon'ble Chancellor vide notification read as paper (2) above, to extend the period for considering the belated applications for affiliation of the new B Voc programmes in twelve colleges during the academic year 2018-19, up to 10.12.2018.

Considering the sanction from the Hon'ble Chancellor and the agreement executed by the Principals and the Managers of the twelve colleges, the University Syndicate vide paper (3) read above, resolved to permit to start the new B Voc Courses noted against the names of the twelve aided arts & science colleges listed below for the academic year 2018-19, subject to the approval of the Government.

As per the U.O. read (4) above the Committee constituted with the Conveners of the Sub Committees of the Syndicate has been assigned the power of the Syndicate for considering and taking decisions in the petitions in connection with the adalath scheduled on 22-02-2019. Accordingly the Committee met on 21.02.2019 considered a petition registered for the adalath regarding the affiliation of B.Voc programmes and resolved to grant provisional affiliation to the new UGC aided BVoc Programmes noted against the names of the twelve aided Arts & Science Colleges listed below for the academic year 2018-19, subject to the approval of the Government,

as per paper read as (5) above, in partial modification of the decision referred to in the paper read as (3) above. Accordingly UO. read as paper (6) is issued.
