#### ORDER

The Government of Kerala vide G.O cited (1) and (2) has issued orders revising the Scale of Pay of teachers in Universities, Affiliated Colleges, teachers in Law Colleges and Engineering Colleges and teachers in Physical Education and Librarians etc. in accordance with the revised 7th UGC Scheme. The Government Order has been endorsed in this University vide endorsement cited (3) above.

The University Grants Commission has vide its notification read as (4) above has issued regulations on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in Higher Education, 2018.

The Government of Kerala also, vide paper read as (5) have accorded sanction to approve and to implement the UGC Regulations 2018 on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in Higher Education as such, with effect from 18.07.2018, the date of publication of the said Regulations in the Gazette of India (Extra ordinary), subject to the exception that where there are any provision in the Regulations inconsistent with the provisions in the Government Order read (1) above, those provisions in the Government Order would override the provisions in the Regulations to the extent of such inconsistency. Government have also ordered that notwithstanding anything contained in the Regulations, only those benefits both monetary and others specified in the G.O's read as (1) and (2) above would be receivable.

The Government Order makes it necessary that the Universities shall incorporate the UGC regulations in the Statutes and in the respective Regulations.

The Regulations published in the gazette of India dated 18.07.2018 by the University Grants Commission vide its notification read as (4) along with the relevant Government Orders were adopted in the University by the Vice - Chancellor exercising the powers conferred under section 10 (17) of Chapter 3 of the Mahatma Gandhi University Act, 1985.

The revised Regulations read along with the relevant Government Orders shall supersede all Regulations issued in this area earlier. The same shall be in force in this University subject to the provisions contained in the Government Orders read as papers (1), (2) and (5).

The full text of the Regulations issued by the UGC is appended to this Order.

Orders are issued accordingly.
