പരാമർശം (1) ശ്രക്കാരം ബിരുദ പ്രോഗ്രാമുകളുടെ (CBCS 2017) പുതുക്കിയ സ്കീം, സിലബസ്, പാഠപുസ്തകങ്ങൾ എന്നിവ അക്കാദമിക് കൗൺസിൽ റഗുലേഷൻ, അംഗീകരിച്ച് ഉത്തരവായിട്ടുണ്ട്.

പരാമർശം (2) പ്രകാരം ബിരുദ പ്രോഗ്രാമുകളുടെ ഭാഷാപുസ്തകങ്ങളുടെ (മലയാളം, ഇംഗ്ലീഷ്) പ്രസിദ്ധീകരണത്തിനായി്ിപ്രിന്റിംങ് ഹിന്ദി, ആന്റ് പബ്ലിഷരുടെ ച)മതല കൺവീനറായി, ജോയിന്റ് രജിസ്ട്രാർ I (ഭരണ വിഭാഗം), വഹിക്കുന്ന അധ്യാപകൻ രജിസ്ട്രാർ ജോയിന് II (ഭരണ്) വിഭാഗം), ജോയിന്റ് രജിസ്ട്രാർ (സാമ്പത്തികം) സമിതിയെ എന്നിവരടങ്ങുന്ന ഒരു നിയോഗിച്ചിട്ടുണ്ട് ബിരുദ പ്രോഗ്രാമുകളുടെ അഞ്ചാം സെമസ്റ്റർ മലയാളം, ഹിന്ദി, ഇംഗ്ലീഷ് എന്നിവയുടെ കോർ കോഴ്സ്, ഓപ്പൺ കോഴ്സ് പാഠപുസ്തകങ്ങളുടെ പ്രസിദ്ധീകരണം സംബന്ധിച്ച് മേൽ സമിതി 13.05.2019 ൽ യോഗം ചേർന്ന് പ്രൂമർശം (3) പ്രകാരം താഴെ പറയുന്ന ശിപാർശകൾ നൽകുകയുണ്ടായി.

The Committee discussed the need for printing and publication of Malavalam, Hindi and English text books of V semester UG Programmes under CBCS regulation 2017 admission, and considered the willingness of various printers to work as co publishers. On the basis of the above, it was resolved to recommend to entrust the following publishers with the printing and publication of Malayalam, Hindi and English text books of the V semester CBCS 2017 admission UG programmes under co publication basis with the University as per the specifications, terms and conditions as detailed below

It was also resolved to recommend to incorporate the following terms and conditions in the Memorandum of Agreement to be signed between the University as the publisher and the above printers as co-publishers.

2. Statement of specifications for printing of the books (Annexure - I, mentioning the number of copies to be printed, quality of paper to be used for text, card to be used for cover, type of printing as to whether multi colour or single colour, type of binding, etc.) shall form part of this agreement.

3. The CO-PUBLISHER shall supply the manuscripts of the material to the PUBLISHER for editing and production. The PUBLISHER will supply the edited, full and final manuscripts to the CO-PUBLISHER for printing.

4. Before the final printing of the book, the CO-PUBLISHER shall take the approval of the PUBLISHER for the text, preliminary pages and the cover.

5. The CO-PUBLISHER undertakes that information in the book has been obtained from sources believed to be reliable and is correct to the best of their knowledge.

6. The PUBLISHER shall in no event be liable for any errors, omissions, disputes on intellectual property, or any damages or loss by whatsoever manner caused to any person, whether the purchaser of the book or not, and disclaim any implied warranty or fitness for any particular use.

7. The CO-PUBLISHER shall at their own cost arrange to clear the copyright for the pieces to be included in the book for which permission is required.

8. The CO-PUBLISHER shall produce the book at their own cost (of production including printing of book. cover design, binding etc.) within 60 days from the date of supply of the typescripts.

9. The published book shall carry the imprints of the PUBLISHER and the CO-PUBLISHER.

10. (a) The copyright of the materials shall rest with the CO-PUBLISHER.
(b) The co-publishing rights of the book shall jointly rest with the PUBLISHER and the CO-PUBLISHER.

11. The published price and print run of the book will be mutually agreed to by the PUBLISHER and the CO-PUBLISHER.

A BARRES

12. The CO-PUBLISHER shall undertake the marketing and distribution of the books. The CO-PUBLISHER shall also be free to sell the books outside the state of Kerala.

13. The CO-PUBLISHER shall be responsible for taking delivery of the printed books from the printer's premises.

14. The CO-PUBLISHER or their permitted assignees or agents shall not revise, copy, or reproduce this book in any form whatsoever, or translate it to other languages without prior written approval of the PUBLISHER.

15. Every new impression / edition / revision will be prepared by the CO-PUBLISHER with the prior written concurrence of the PUBLISHER S

16. Should it be found necessary to increase prices of subsequent editions of the book due to increase in cost of production, the CO-PUBLISHER shall obtain prior written permission from the PUBLISHER before doing so.

17. The CO-PUBLISHER shall give 12 copies of each book free of cost to the PUBLISHER and 5 copies to the respective contributor (writer / legal heir) and the same shall hold good for subsequent editions.

18. The CO-PUBLISHER shall pay an advance royalty of Rs.2000/- (Rupees Two Thousand Only) which will be adjusted against the future royalty statements. The payment shall be made by Demand Draft drawn in favour of the Director, Department of Printing and Publishing, Mahatma Gandhi University, and payable at State Bank of India, Mahatma Gandhi University Campus Branch.

19. The CO-PUBLISHER shall make half yearly statement of sales as on stat of March and 30th of September, and shall pay the PUBLISHER a royalty at the rate of 12.5% (twelve and a half per cent) of the published price on all copies sold, by way of Demand Draft drawn in favour of 'The Director, Department of Printing and Publishing, Mahatma Gandhi University', payable at State Bank of India, Mahatma Gandhi University Campus Branch, not later than the date of sales statement. The CO-PUBLISHER is also liable to furnish sale statements to the PUBLISHER as and when demanded.

20. The CO-PUBLISHER shall handover 50 copies of the book to the PUBLISHER on sale or return basis. The PUBLISHER shall prepare annual statement of sale of books by 31st March and hand over the same to the CO-PUBLISHER along with the amount due after deducting trade discount, by way of Demand Draft before 31st of May every year.

21. The CO-PUBLISHER shall not produce titles similar to the book, or draw agreements with other publishers to produce titles similar to the book.

22. The rights of the CO-PUBLISHER under this agreement shall not be assigned in any manner without the prior written permission of the PUBLISHER.

23. It is agreed by the parties to this agreement that if any dispute arises in furtherance of the performance of this agreement, only the courts at Kottayam shall have jurisdiction to entertain the dispute.

24. The agreement shall be valid till all the copies of this book are exhausted, or for 5 years, whichever is earlier.

25. If the CO-PUBLISHER violates any of the conditions in the agreement, the PUBLISHER shall have the right to cancel the agreement at any time.

The Committee also resolved to recommend to incorporate in the agreement with Malayalam co-publisher the provisions of Clause 6 and 9 (a) amended as follows:

Clause 6: The PUBLISHER will take steps to clear the copyright of the pieces to be included in the book obtaining permission from the authors / copyright holders and the remuneration payable to them will be paid by the CO-PUBLISHER to the PUBLISHER for payment directly to the authors / copyright holders.
