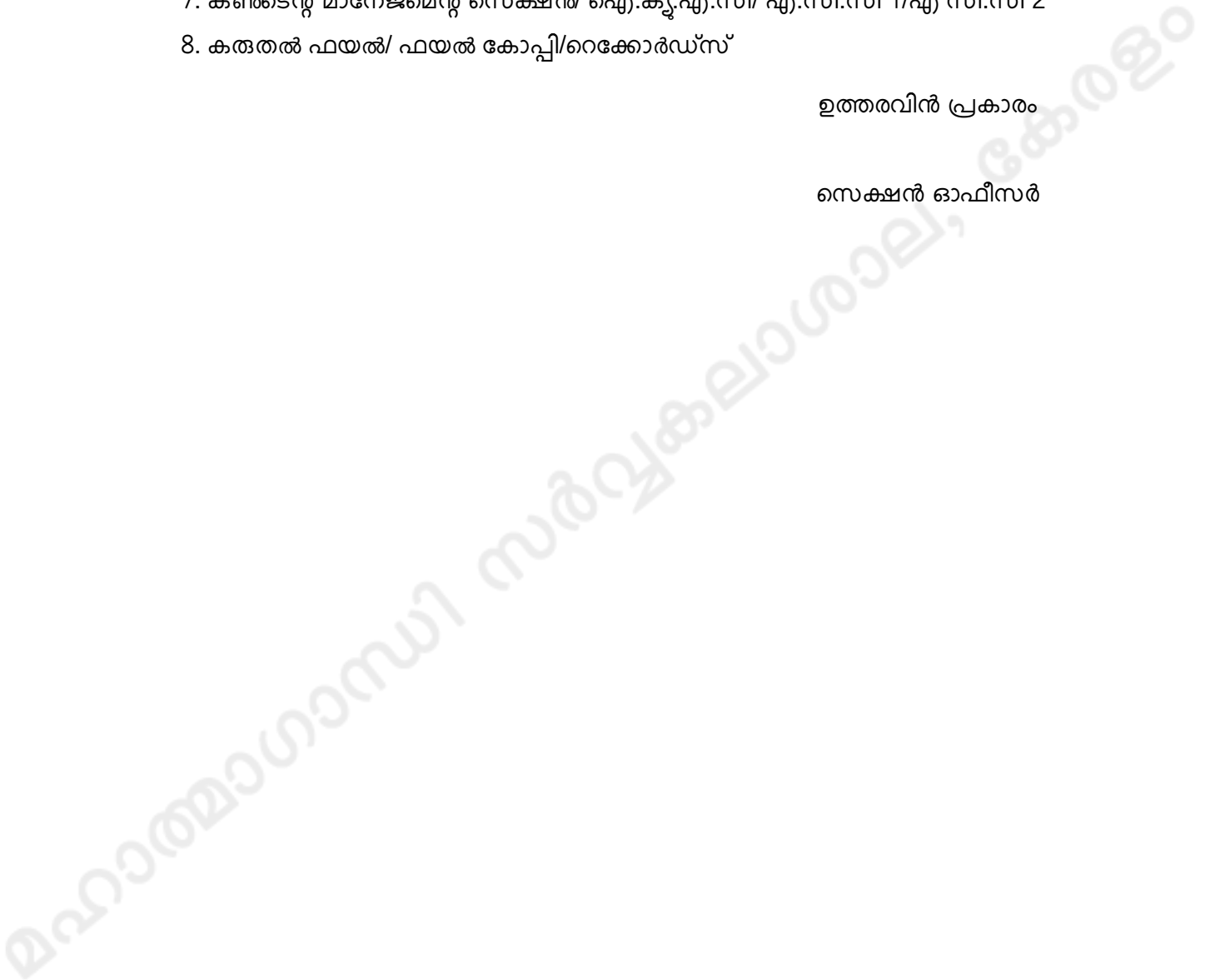



The meeting started at 10.00 a.m with Hon'ble Vice Chancellor in the chair. The meeting discussed the ICCR sponsored and self supported applications of International Students to various programmes in the academic year 2019-20, on case by case basis relating with the remarks of the dean, eligibility criteria and the relevant clauses given in the Regulation(10.1) for Admission of International Students (No Ac.L/1/1/2016/RINS dated 9.9.2016) and has decided the following.

1. Decided to sanction Provisional Admission to 18 students in P.G Programme and 5 students in Ph.D Programmes(Based on No.4990/A.C.A XII/1/144/UCIC/2018 dated 19.06.2018) in University Schools (list attached)
2. Provisional Admissions are granted and it will be confirmed only after verifying the certificates and other documents in original upon arrival.
3. Entrust the Honorary Director, UCIC to forward the confirmation list to ICCR/to respective candidate in case of Self Supporting Applicants.
4. The students are advised to report the University in order to join for the programme in the respective department/college on or before July 15<sup>th</sup> for P.G Programme and August 19<sup>th</sup> for Ph.D Programme.
5. All the international students joining in University Departments/Schools have to stay in the International Student hostel managed by University Center for International Co-operation or the Hostel facility provided by respective colleges.
6. Entrusted the Director, UCIC to inform the affiliated colleges(by email to the Principal) about the 10 percentage additional reservation for foreign students in all programmes and the University Admission formalities with Brochure in order to attract more students in M.G University.
