It is hereby notified that the last date for submission of applications for the ensuing VI Semester CBCSS Undergraduate Examinations (Prior to 2013 Admission- Supplementary/Mercy Chance) is 17.12.2019 (without fine), 19.12.2019 (with a fine of ₹525/-) and 23.12.2019 (with a superfine of ₹1050/-). The candidates shall also remit a sum of ₹30/- towards the cost of application form and ₹35/- per paper subject to a maximum of ₹210/- towards C.V Camp fee, in addition to the prescribed examination fee. The candidates of 2009 admission shall remit a sum of ₹10,500/- (Rupees Ten thousand and Five Hundred only), the candidates of 2010 admission shall remit a sum of ₹7,350/- (Rupees Seven thousand Three Hundred and Fifty only) and the candidates of 2011 admission shall remit a sum of ₹5,250/- (Rupees Five thousand Two Hundred and Fifty only) as special fee in addition to the prescribed examination fee. Note that the candidates of 2019 admission shall remit a sum of ₹5,250/- (Rupees Five thousand Two Hundred and Fifty only) as special fee in addition to the prescribed examination fee.

The last date for submission of applications for the ensuing IV Semester CBCSS Undergraduate Examinations (Prior to 2013 Admission- Mercy Chance) is 17.12.2019 (without fine), 19.12.2019 (with a fine of ₹525/-) and 23.12.2019 (with a superfine of ₹1050/-). The candidates shall also remit a sum of ₹30/- towards the cost of application form and ₹35/- per paper subject to a maximum of ₹210/- towards C.V Camp fee, in addition to the prescribed examination fee. The candidates of 2009 & 2010 admissions shall remit a sum of ₹10,500/- (Rupees Ten thousand and Five Hundred only), the candidates of 2011 admission shall remit a sum of ₹7,350/- (Rupees Seven thousand Three Hundred and Fifty only) and the candidates of 2012 admission shall remit a sum of ₹5,250/- (Rupees Five thousand Two Hundred and Fifty only) as special fee in addition to the prescribed examination fee and C.V Camp fee.

The candidates who have already remitted the special fee for CBCSS examinations (Mercy Chance –I,II, III, & V Semesters) conducted during the year 2019 need not remit the same again. But they shall remit the balance amount of Mercy Chance Fees and furnish a copy of the e-receipt regarding the remittance of special fee along with the application.

The date of commencement of examinations and the detailed time table shall be announced later.

The application form can be downloaded from the official website of the University, Candidates shall remit the fees through <u>epay.mgu.ac.in</u>. The last dates stipulated above are not only for the remittance of examination fee, but for the receipt of applications in the University Office. Applications received after the last dates will be summarily rejected.
