Read:- Minutes of the Board of Studies meeting (B.Arch./M.Arch.) held on 22.01.2020.

**ORDER**

In connection with the syllabus revision of B.Arch courses, the meeting of Board of Studies (B.Arch./M.Arch. Combined) was held on 22.01.2020. The Board discussed matters regarding finalization of B.Arch Revised Regulation, preparation of Model Question Papers, determination of the eligibility criteria for internal Re-do, Syllabus verification of M.Arch (Urban Design) and clarification on the issues regarding the failure in Architectural Design Paper, and the following recommendations were placed before the Hon'ble Vice – Chancellor for consideration.

1. B.Arch – Preparation of Model Question Papers :-  
Recommended to approve the model question paper pattern for Semester I & II (due in 2020 May) B.Arch Degree Examination. The BOS also recommended to approve the question paper pattern for all written examination papers for M.Arch Degree Examination in Landscape Architecture.
2. B.Arch – Internal Re-do Criteria  
The BOS recommended to have no change in the contents of clause 14.2.1 of B.Arch regulations of 2019.
3. Clarification in matters regarding failure in Architectural Design Paper –  
The BOS meeting noted that in B.Arch regulations 2019, part B. Manual of Clause 19.1.18 it is stated that, “students who could not get minimum pass marks for the subject (Group 1(a) Subjects i.e., Architectural Design I & II to VII and IX) even after the make up jury shall repeat the Course work for that subject along with the next batch of students. The BOS recommended to include the following in continuation to the above quoted sentence “and such students shall not be promoted to their higher semesters.”
4. M.Arch (Urban Design) Syllabus verification.  
The BOS scrutinized the above syllabus and scheme as well as programme structure and recommended that the same may have uniformity with that of M.Arch Landscape Architecture which is already approved by the University.

The Hon'ble Vice Chancellor has approved the above recommendations of the Board of Studies (B.Arch / M.Arch. Combined).

Orders are issued accordingly.

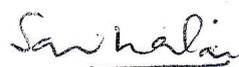
