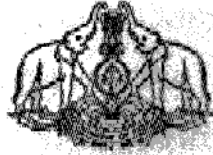

Lockdown declared in the nation consequent to the Novel Corona Virus (Covid-19) outbreak - Extension of Deputation of Officers on Deputation during the Currency of lockdown- Orders Issued

**ORDER**

As per Rule 140 (c) Part I, Kerala Service Rules, persons continuing on deputation without prior sanction of Government will be liable for disciplinary action and no ex post facto approval for regularization of overstay on foreign service shall be allowed. The period of overstay shall not be counted for the purpose of pension and that any increment due during the period of overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre. The officer shall be precluded from drawing pay and allowances from the date on which the sanctioned term of foreign service expires.

2. Several instances have come to the notice of the Government that the Administrative Departments could not issue orders for extension of deputation of the officers in advance or re-post them in the parent department on reversion from deputation, in view of the lockdown declared in the nation consequent to the Novel Corona Virus (Covid-19) outbreak. If orders extending the deputation are not issued, the officers will be reverted to their parent department and due to non-availability of sufficient vacant posts these officers have to either wait for posting orders compulsorily and get the period regularized only as eligible leave or have to face disciplinary action as per Rule 140(c), Part I, Kerala Service Rules,

in the event of continuance on deputation without Government sanction.

3. In order to overcome the present situation of having to overstay on deputation, Government are pleased to order that deputation of officers whose sanctioned term expires during the currency of lockdown are treated as extended till 31.05.2020 in relaxation of Rule 140(c), Part I, Kerala Service Rules and they will be reverted to their parent department on 31.05.2020, unless the competent authority extended the period of deputation on or before 31.05.2020.
