The University Research Committee held on 24.06.2019, vide the paper read as (2) above, resolved to recommend to accept the title of the research work as approved in the Pre-Ph.D. Presentation, as final, and to issue the certificate for the same, as per the report of the Pre-Ph.D. Presentation, from 2016 Admission onwards.

Clarifications were sought regarding receipt of applications for change of title from scholars of 2016 Admission onwards. The meeting of the University Research Committee held on 20.01.2020, discussed the matter in detail and resolved, vide the paper read as (3) above, to recommend to put forward the following suggestions regarding the receipt of applications, from scholars of 2016 admission onwards, for change of title.

- Any proposal for the change of title of research work shall be considered at the time of Pre-Ph.D. Presentation.
- 2. Change of title shall be noted in the report of Pre-Ph.D. Presentation.
- 3. The fee towards 'Change of title' as prescribed by the University from time to time shall be remitted by the scholar.

- 4. Authorize the Assistant Registrar concerned, to issue University orders regarding change of title, on the basis of the report of Pre-Ph.D. Presentation.
- 5. Authorize Director of Research to issue certificate of Pre-Ph.D. Presentation by including the new title, as per the University order issued in this regard.
- 6. Cancel U. O. No. 548/2019/AX/Gen/Academic dated 01.02.2019.
- 7. Modify Item No. III of the Minutes of the meeting of the University Research Committee held on 24.06.2019. 68.00
