ORDER

As per the Government Orders read as 1st to 7th above supernumerary posts were created for appointment under the Compassionate Employment Scheme (CES) considering the inordinate delay in giving appointments to the dependents of deceased employees on condition that the supernumerary posts so created would be adjusted against the regular turn of applicants. As per the Government Order read as 8th above norms were fixed regarding service conditions of candidates appointed against such supernumerary posts and it was specified that regularisation of appointment should be done based on the date of occurrence of vacancies to which they were entitled as per the 5% quota compassionate employment till for and such earmarked regularisation they would continue to be in the supernumerary posts and that their probation would commence from the date of absorption to regular vacancies to which they are entitled as per the guota earmarked for compassionate appointment. Now a doubt has been raised as to whether they are eligible for increment before regularisation.

2. The G.O read as 8th paper above does not contemplate service benefits like increment etc to supernumerary employees appointed under Compassionate Employment Scheme. Therefore increment and other service benefits are normally admissible only after regularisation of appointment against 5% vacancies. It has come to the notice of the Government that since their regularisation of appointment is a time consuming process, they will be drawing only the minimum of the time scale for many years.

3. Government have examined the matter in detail and are pleased to order that the candidates appointed against supernumerary posts created for appointment under the Employment Scheme Compassionate will be granted annual increments, with effect from the first day of the month in which they complete one year duty reckoned with effect from the date of joining in the supernumerary post, subject to satisfaction of the conditions under Rule 33 Part 1 of the Kerala Service Rules. Their pay on regularisation will be fixed at the same stage as drawn immediately before regularisation. Their subsequent increments will be regulated

as follows:-

(i)Where the period of probation is two years, the next two increments after regularisation will be drawn on the normal increment date and the third increment will also be drawn on the normal date provided that probation is declared before that date. In the event of declaration of probation after the normal date of increment, the third increment will be drawn only with effect from the date of effect of declaration of probation.

(ii)Where the period of probation is one year, the next one increment after regularisation will be drawn on the normal increment date and the second increment will also be drawn on the normal increment date provided that probation is declared before that date. In the event of declaration of probation after the normal date of increment, the second increment will be drawn with effect from the date of effect of declaration of probation.

(iii) Where the date of effect of regularisation and the date of increment happen to be the same, subsequent increments will be drawn subject to Rule 37 B (a) and (b) Part I of the Kerala Service Rules.

4. Granting increments under these orders will not confer upon them any preferential claim for regularisation or seniority over those appointed in regular vacancies through the Kerala Public Service Commission or any other service benefits like Time Bound Higher Grade, Promotion etc. Nor will the supernumerary service period be reckoned for service weightage for Pay Revision. 5. Necessary amendments to the Kerala Service Rules, Part 1 will be issued separately.
