**ORDER**

In the context of lock down and the prospect of disruption of classes in the future due to similar crises, a video conference was held by the Hon'ble Minister for Higher Education with the Vice Chancellors of the State Universities. Based on the discussions therein, a Committee has been constituted under the Chairmanship of Dr. Ekbal, Member (Education and Health) Planning Board and former Vice Chancellor, University of Kerala, to make recommendations on the extent of changes to be brought about in pedagogy, conduct of examinations and evaluation, going forward.

Government are also pleased to issue the following directions to the Universities and other Higher Education Institutions for the conduct of examinations and valuation of answer scripts:

- i) Universities shall make arrangements for conducting the balance examinations starting May 11, 2020 and home valuation starting April 20, 2020. The examinations may be conducted in such a manner that they can be completed in a week's time. Sufficient notice must be given to the students. Examinations must also be held by following all safety precautions laid down by Health Department issued for containment of the COVID 19 spread and also the directions issued vide GO(Ms)No. 78/2020/GAD dated 17/04/2020.
- ii) Universities are encouraged to try out on-screen marking system in some subjects where valuation is pending. Director, IHRD is directed make presentations to all Universities on the on- screen marking system that is developed and can be administered by them.
- iii) Universities should take care to put an end to false numbering and use only unique/bar coded answer sheets for examinations starting next academic semester.
- iv) Universities shall conduct online classes and provide online assignments for

students. They are requested to partner with ASAP in the on going webinars and online classes for college students and the MOOC courses for faculty on Online Learning and Content Development conducted under the FLAIR initiative of Directorate of Collegiate Education.

v) Universities shall take steps to keep their libraries open for research students, by following all safety precautions laid down by Health Department.

vi) Universities shall take steps for conduct of contact classes for students of Distance Education using digital/online means.

**ORDER**

As per the Government Order read above, Government have issued directions encouraging the Universities to make arrangements for conducting the balance examinations starting May 11, 2020 onwards after following all safety precautions laid down by Health Department issued for containing COVID-19 spread and also the directions issued vide G.O.(Ms.) No.78/2020/GAD dated 17.4.2020.

Government have received petitions suggesting that examinations be held only after flights and trains resume as the country is in a locked down situation till May 3rd, 2020. Government are pleased to clarify that the Universities may decide the suitable dates for conducting the remaining examinations after the easing of restrictions in the State and in their respective geographical jurisdictions, while observing Government directions, if any, to be issued in public interest.


