**Minutes of the meeting of the International Students Admission Committee
held on 10.06.2020**

Venue: Vice Chancellor's Chamber



The meeting started at 10.00 a.m with Vice Chancellor in the chair. The meeting discussed the ICCR sponsored and self supported applications of International Students to various programmes in the academic year 2020-21, on case by case basis relating with the remarks of the dean, eligibility criteria and the relevant clauses given in the Regulation(10.1) for Admission of International Students (No Ac.L/1/1/2016/RINS dated 9.9.2016) and has decided the following.

1. Decided to sanction Provisional Admission to 50 students(as attached) to various programmes under Schools and Affiliated Colleges.
2. Provisional Admissions are granted and it will be confirmed only after verifying the certificates and other documents in original upon arrival. The ICCR/candidates has to pay the tuition fee and other fee as per regulation.
3. Entrust the Honorary Director, UCIC to forward the provisional admission confirmation to ICCR or to respective candidate.
4. The students are advised to report the University in order to join for the programme in the respective department/college **only after 1st October but before 15th October 2020**. In case the University start classes online before these dates the students can join on-line but their admission will be confirmed only after verification of the certificate in Original upon arrival. Entrust the honorary director to make a format to enroll into the program(e-join) in case University starts the first semester class before the arrival of International Students. Upon arrival the candidates has to submit a COVID-negative certificate from relevant medical authority from their country and to obey all the precautions imposed by Medical Authorities in the state including Quarantine. Request ICCR to insist Medical Insurance compulsory to join in any course in India.
5. All the international students joining in University Departments/Schools have to stay in the International Student hostel managed by University Center for International Co-operation or the Hostel facility provided by respective colleges or the Private Accommodation arranged by UCIC in this regard. The students from ICCR has to contribute the rent in advance which has to be reimbursed to the students as and when ICCR pay the rent later.

The meeting concluded at 11 a.m.
