ORDER

The Principals of Al-Azhar Law College, Thodupuzha, Bharata Mata School of Legal Studies, Aluva, Co-Operative School of Law, Thodupuzha, CSI College for Legal Studies, Kanakkary, Ettumanoor, and Sree Narayana Law College, Poothotta vide paper (1) read above, requested to grant extension of provisional affiliation to the self financing colleges and courses for the Academic Year 2020-21.

The University considered the applications submitted by the Colleges and Inspection Commissions were constituted vide paper (2) read above, to assess the infrastructural and instructional facilities available in the Colleges for the extension of provisional affiliation for the Academic Year 2020-21 and the Commissions have duly submitted the reports recommending the extension of provisional affiliation to the self financing colleges and courses for the Academic Year 2020-21.

Considering the above, the Syndicate Sub Committee on Affiliation, vide paper (3) read above, recommended to grant extension of provisional affiliation to the five unaided Law Colleges and their courses. The Vice- Chancellor, exercising powers under Chapter 3, Section 10(17) of Mahatma Gandhi University Act 1985, has approved the above recommendation and granted provisional affiliation to the five unaided Law Colleges and their courses for the Academic Year 2020-21 as detailed below:

- 5. Non-Compliance with any of the above conditions would lead to the withdrawal of the affiliation without prior notice.
