ORDER

As per Mahatma Gandhi University Ph.D. Regulations 2016, regular and permanent teachers from the Government/Aided Colleges in the state and from the University Departments/Inter-University Centres/University Inter-School Centres are exempted from appearing for the Ph.D. Entrance Test. Sri A. Abdul Vahab, General Secretary, Self Financing College Teachers and Staff Association, has submitted a letter, vide the paper read as (2) above, requesting exemption also for experienced Self Financing College Teachers from appearing for the General Aptitude Test (Entrance Test) conducted by the University, every year for Ph.D. registration.

The Syndicate Sub Committee on Research and Development held on 17.06.2020, after having considered this, resolved, vide the minutes read as (3) above, to recommend that teachers working in self-financing colleges under the control of Government, with three years continuous teaching experience, shall be exempted from Ph.D. Entrance Test.

The Vice-Chancellor, exercising powers of the Syndicate, under Section 3.10(17) of Mahatma Gandhi University Act 1985, has approved the above recommendation of the Syndicate Sub Committee on Research and Development.

Orders are issued accordingly.
