# AMENDMENT TO THE MAHATMA GANDHI U VIVERSITY STATUTES, 1997.

In exercise of the powers conferred by Section 23(ii) of the Mahatma Gandhi University Act, 1985, the Syndicate of the University at its meeting held on 29.10.2011 (Item No.OA.1/11.08/ (Lub Item OA.3)) has made the following amendment to the Mahatma Gandhi University Statutes, 1997.

## Amendment No.14

## **Existing Statutes**

#### **Amended Statutes**

#### Chapter 45, Part B, Statute 14.

Age limit for direct appointment

The minimum age limit and the maximum age limit for appointment by direct recruitment of Lecturers in private Aided. Arts and Science colleges shall be 23 (Twenty-three) and 36 (Thirty six) respectively as on the first day of July of the year in which applications for appointment are invited, with the usual relaxation of age limits to members of SC/ST/OBC. Communities as in Government Service.

Provided that the upper age limit shall be relaxable by five years, in the case of persons who are in service as teachers in Government/Private Aided High Schools, Vocational Aided Government/Private Secondary Schools Higher Aided Higher Government/private Secondary Schools for appointment as Lecturers in private Aided Arts and Science Colleges".

## Chapter 45, Part B, Statute 14.

Age limit for direct appointment

The minimum age limit and the maximum age limit for appointment by direct recruitment of Assistant Professors in private Aided Arts and Science colleges shall be 22 (Twenty-two) and 36 (Thirty six) years respectively as on the first day of July of the year in which applications for appointment are invited, with the usual relaxation of age limits to members of SC/ST/OBC Communities as in Government Service.

Provided that the upper age limit shall be relaxable by five years, in the case of persons who are in service as teachers in Government/ Private Aided High Schools, Government/ Private Aided Vocational Higher Secondary Schools and Government/Private Aided Higher Secondary Schools for appointment as Assistant Professors in private Aided Arts and Science Colleges".

The Secretary to Governor, vide letter No.GS3-231/2012, dated 7<sup>th</sup> May, 2012, has intimated that the above amendment to the Mahatma Gandhi University Statutes, 1997 was assented to by H.E. the Chancellor on 05.05.2012. This amendment shall be deemed to have come into force with effect from 05.05.2012.
