ORDER

The University Research Committee, vide the item read as (1) above, had discussed in detail about the maximum period of research to be granted to the Research Scholars registered from 2016 Admission onwards (coming under the purview of MGU Ph.D. Regulations 2016), whose Supervising Teachers subsequently coming under retired / adjunct / deputation / transferred category. The Committee resolved to recommend to grant research period admissible as per Ph.D. Regulations 2016 and the scholars shall apply for change of supervising teacher at the time of the retirement of present Supervising Teacher. The matter was placed before the Syndicate as per the orders of the Vice-Chancellor dated 26.03.2019.

Regarding the period of research of scholars, under Supervising Teachers of retired / adjunct / deputation / transferred category, the Syndicate had taken decision to grant extension of time limit of research period upto 30.06.2019 and later in the wake of the Lock down due to Covid-19 pandemic, it was again extended upto 30.12.2020, vide the University Order cited (2).

Considering the constraints faced by the Research Scholars due to the shortage in availability of new Research Supervisors, permission has been granted by the Vice-Chancellor, exercising powers of the Syndicate under Section 3.10(17) of Mahatma Gandhi University Act 1985, to the Research Scholars, who registered from 2016 Admission onwards and their Supervising

Teachers subsequently coming under retired/adjunct/deputation/transferred category, to continue their research under the existing guides for a maximum period of six years from the date of effect of registration.

Orders are issued accordingly.
