**ORDER**

The Pre-Ph.D. Presentations of Research Scholars from the Approved Research Centres of the University are normally conducted in University Statutory Departments wherein the conduct of Pre-Ph.D. Presentation in a particular subject is assigned with. In the wake of Covid-19 pandemic, Research Scholars have expressed their inconvenience and difficulty to reach Mahatma Gandhi University Departments for Pre-Ph.D. Presentation.

In the wake of the prevailing situation due to Covid 19 pandemic permission has already been granted, vide the University Order cited, to conduct Pre-Submission Viva of Ph.D Thesis through online video conference, if needed, in addition to the existing mode.

In continuation of the above order and considering the requests of Research Scholars, sanction has been accorded by the Vice-Chancellor, exercising powers of the Syndicate under Section 3.10(17), of Mahatma Gandhi University Act 1985, to permit the Heads of Statutory Departments and Heads of Approved Research Centres to conduct Pre-Ph.D. Presentations of Research Scholars of University Research Centres and Approved Research Centres respectively, through online Video Conference.



The Heads of Statutory Departments shall make necessary arrangements for conducting the online Pre-Ph.D. Presentation of Research Scholars under their Research Centres. The Heads of Approved Research Centres shall make necessary arrangements in their own Research Centres for conducting Pre-Ph.D. Presentation of their Research Scholars through online Video Conference and shall provide its link in time to the Heads of the University Statutory Departments concerned. The Heads of University Statutory Departments concerned must attend the online Pre-Ph.D. Presentations being conducted in Approved Research Centres and shall submit Report of the Pre-Ph.D. Presentation, to the Director of Research.

Orders are issued accordingly.


