<u>ORDER</u>

The applications submitted by various Educational Agencies, vide paper read (1) above, for starting New Programmes/ Additional Batches/Permanent Seat Increase in existing Unaided/Self-financing Arts & Science Colleges during the Academic Year 2020-21, were considered by the University and Inspection Commissions were constituted vide ref (1),(2),(3),(4),(5),(6),(7),(8),(9) & (10) above, to assess the instructional and infrastructural facilities provided by the respective Educational Agencies to start the proposed courses.

The late application submitted by Marian International Institute of Management, Kuttikkanam, Idukki was considered by the Syndicate and resolved to recommend to seek Hon'ble Chancellor's permission to extend the time for considering the belated application up to 30.06.2020, vide ref (11) and requested the Hon'ble Chancellor to extend the time limit for considering the application up to 30.06.2020. Hence the matter was brought to the notice of the Hon'ble Chancellor vide ref. (12). As per reference (13), permission has been granted by the Hon'ble Chancellor to the Syndicate to consider the said application in accordance with the provisions of the University Act and Statutes within 30.06.2020.

The Syndicate resolved to recommend to seek Hon'ble Chancellor's permission to extend the time for completing the procedures on the applications submitted vide ref (1) up to 30.06.2020 in the wake of COVID-19 pandemic vide ref (14) and requested the Hon'ble Chancellor to extend the time limit for considering the applications up to 30.06.2020 vide ref (15). As per reference (16), permission has been granted by the Hon'ble Chancellor to the Syndicate for completing the procedures on the said applications in accordance with the provisions of the University Act and Statutes within 30.06.2020.

The Syndicate Sub Committee on Affiliation examined the Inspection Commission Reports in detail and the recommendations of the University to start the proposed Programmes were forwarded for the NOC of the Government of Kerala vide ref (19) & (20).

The Government of Kerala, vide paper (21) above, accorded administrative sanction to the following self financing colleges for starting new Programmes/Additional Batches/Enhancement of seats during the Academic Year 2020-21.

Sanction has therefore been accorded by the Vice-Chancellor u/s 3.10(17) of the M G University Act,1985 to the following Colleges for New Programmes/Additional Batch/Permanent Seat Increase in existing self financing courses subject to the verification of the compliance of Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty, qualifications etc. and to include the programmes in the Centralised Allotment Process (CAP) 2020.

Provisional affiliation is granted subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one Academic Year only.
- 2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. As per G O read (21) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

- b) Students insurance premium @ Rs.25/- per student per year.
- c) Students welfare fund @ Rs. 30/- per student per year.
- d) University Union fee @ Rs. 55/- per student per year.

e) Sports affiliation fee @ Rs. 210/- per student per year to be utilised in the ratio 50:50 by the University and the college

f) The collection of annual administration fee from the students under any circumstances is not permitted.

g) Student's affiliation fee @ Rs. 550 & 750 /- for UG & PG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing of the admission.
5. The rate of Tuition Fee is as per University and Government orders issued from time to time.

6.The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Principal of the college shall endorse the undertaking.

7.The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.

8.Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.

Orders are issued accordingly.
